ITEM: AUTHORIZATION TO AWARD TWO CONTRACT FOR WELLFIELD REHABILITATION AND MAINTENANCE

REQUEST: Authorization to award contracts to All Webbs Enterprises, Inc. and Florida Design Drilling Corporation for wellfield rehabilitation, maintenance.

EXPLANATION: The Utility Department operates and maintains eighteen (18) surficial aquifer wells that provide the raw water for our potable water supply system. As a normal part of operations planning, the department had JLA Geosciences evaluate the condition of the existing well fields a make recommendations for improvements that would optimize performance and extend their life cycle. All of the wells were drilled between 20 and 30 years ago. This contract will be used to effectuate the JLA recommendations to ensure a sustainable water supply.

On August 23, 2020, Wellington released ITB 202034 on Demandstar, seeking qualified firms to provide these services. The solicitation was also advertised in the Palm Beach Post and posted on Wellington's website. On October 23, 2020, four (4) proposals were received.

Staff recommends awarding contracts to the two lowest, responsive, responsible bidders, All Webbs Enterprises, Inc. and Florida Design Drilling Corporation, and utilizing the unit prices provided by each to determine the lowest priced vendor on a project by project basis. Projects exceeding \$25,000 will be brought back to Council for individual approval. .
