A RESOLUTION OF THE BOARD OF SUPERVISORS OF ACME IMPROVEMENT DISTRICT, VILLAGE OF WELLINGTON, PALM BEACH COUNTY, FLORIDA, APPROVING CONSIDERATION OF THE ADOPTION OF A PLAN OF IMPROVEMENTS FOR UNIT OF DEVELOPMENT 50th STREET

WHEREAS, Acme Improvement District (hereafter "District") is a dependent special district duly organized and validly existing under the Constitution and the Laws of the State of Florida, including the applicable provisions of Chapter 298, Florida Statutes, and Chapter 2003-330, Laws of Florida, as amended, (together the "Act"); and

WHEREAS, Chapter 2003-330, Laws of Florida, provides for the creation of separate Units of Development within Acme's jurisdictional boundaries and pursuant to said authority Acme did previously form its Unit of Development 50th Street; and

WHEREAS, in accordance with the Act, Acme's Engineer has prepared and submitted a proposed Plan of Improvements for Acme's Unit of Development 50th Street, a true and correct copy of which is attached hereto and identified as Exhibit "A".

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL ACTING IN ITS CAPACITY AS THE BOARD OF SUPERVISORS OF ACME IMPROVEMENT DISTRICT, AS FOLLOWS:

- <u>Section 1</u>. The Wellington Council, in compliance with the Equestrian Preserve Element of its Comprehensive Plan, has approved the paving of a portion of 50th Street, which is located within Wellington's Equestrian Preserve Area.
- <u>Section 2.</u> The Board of Supervisors does hereby approve for consideration the adoption of the attached proposed Plan of Improvements for its Unit of Development 50th Street.
- **Section 3**. The Board of Supervisors does hereby direct the filing of this Resolution with the Secretary of Acme.
- <u>Section 4</u>. The Board of Supervisors does hereby direct the preparation and publication of the initial Notice of Public Hearing required by Section 298.301, Florida Statutes, on the attached proposed Plan of Improvements for Unit of Development 50th Street.
- <u>Section 5</u>. The Board of Supervisors does hereby direct that a copy of the aforementioned Notice of Public Hearing be served by first class U.S. Mail on those required to be so served pursuant to the applicable provisions of the Act.
- **Section 6.** The Board of Supervisors does hereby direct that a copy of the attached proposed Plan of Improvements for Unit of Development 50th Street be submitted to the South
