**ORDINANCE NO. 2022-25**

**AN ORDINANCE OF WELLINGTON, FLORIDA'S COUNCIL  
AMENDING THE CODE OF ORDINANCES BY REPEALING  
AND REPLACING CHAPTERS 1, 2, 3, 6, 14, 18, 22, 23, 26,  
27, 30, 33, 35, 36, 38, 42, 46, 50, 54, 58, 62, 66, 70, 71, AND  
72 IN THEIR ENTIRETY, AS CONTAINED HEREIN;  
PROVIDING FOR CONFLICT; PROVIDING FOR  
CODIFICATION; PROVIDING FOR SEVERABILITY; AND  
PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the Wellington Council, as the governing body, pursuant to the authority vested in it by Article VIII, Section 2 of the Florida Constitution, and Chapter 166 of the Florida Statutes, is authorized and empowered to adopt legislation to govern the affairs of its citizens; and

**WHEREAS**, Wellington adopted its first Code of Ordinances in 1997, shortly after incorporation, and since that time has adopted revisions as necessary to protect the health, safety and welfare of its citizens; and

**WHEREAS**, Wellington believes that it is in the best interest of the community to make additional modifications to the Code of Ordinances to update the Code, remove outdated and unnecessary provisions, and to simplify the provisions set forth therein; and

**WHEREAS**, the Wellington Council, after notice and public hearings, has reviewed and adopted on first reading the following ordinances:

**WHEREAS**, all of the ordinance numbers listed in the table above shall be replaced by this Ordinance 2022-25 and all exhibits from previous ordinances will be combined in Exhibit A of this ordinance in order to adopt the entire Code of Ordinances under a single ordinance; and

**WHEREAS**, the Wellington Council has taken the recommendations of Wellington's staff and the comments of the public into consideration as part of the review of the proposed amendments to the Code of Ordinances that are the subject of this Ordinance.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF WELLINGTON, FLORIDA:**

**SECTION 1.** Chapters 1, 2, 3, 6, 14, 18, 22, 23, 26, 27, 30, 33, 35, 36, 38, 42, 46, 50, 54, 58, 62, 66, 70, 71, and 72 of Wellington's Code of Ordinances are hereby repealed in their entirety.

**SECTION 2.** Wellington hereby adopts the entirety of the regulations set forth in Exhibit A, attached hereto as its new Code of Ordinances.

**SECTION 3.** Appendix A to Wellington's existing Code of Ordinances remains unchanged by this Ordinance.

**SECTION 4.** Should any section, paragraph, sentence, clause, or phrase of this Ordinance conflict with any section, paragraph, clause or phrase of any prior Wellington Ordinance, Resolution, or Municipal Code provision; then in that event the provisions of this Ordinance shall prevail to the extent of such conflict.

**SECTION 5:** Should any section, paragraph, sentence, clause, or phrase of this Ordinance be declared by a court of competent jurisdiction to be invalid, such decision shall not affect the validity of this Ordinance as a whole as a whole or any portion or part
