**A RESOLUTION OF WELLINGTON, FLORIDA'S COUNCIL
APPOINTING MEMBERS OF THE AFFORDABLE HOUSING
ADVISORY COMMITTEE CONSISTENT WITH ORDINANCE
NO. 2022-04 AND SECTION 420.9076, FLORIDA
STATUTES; AND PROVIDING AN EFFECTIVE DATE.**

WHEREAS, on March 22, 2022, the Wellington Council adopted Ordinance No. 2022-04, establishing the Affordable Housing Advisory Committee pursuant to section 420.9076, Florida Statutes; and

WHEREAS, section 420.9076, Florida Statutes, provides that the Wellington Council shall appoint at least 8 but not more than 11 committee members and that the committee must consist of at least one member of the Wellington Council and one representative from at least 6 of the categories listed in section 420.9076(a)-(k); and

WHEREAS, Ordinance No. 2022-04 provides that the Wellington Council shall, by resolution, appoint the members of the Affordable Housing Advisory Committee for a term of 3 years consistent with the requirements of section 420.9076, Florida Statutes; and

WHEREAS, the Wellington Council now desires to appoint the initial members of the Affordable Housing Advisory Committee pursuant to Ordinance No. 2022-04 and section 420.9076, Florida Statutes, as set forth herein.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF WELLINGTON, FLORIDA, that:
