**WHEREAS,** Wellington's Manager recommends approval of the Budget Amendment.

**SECTION 2.** The Wellington Council hereby approves the Budget Amendment #2022-009 as set forth in Exhibit "A" and authorizes the Mayor to execute the Amendment as presented.
