Subject: Sales Surtax Revenue & Expenditure Report

The purpose of this memo is to provide the Parks & Recreation Advisory Board with the Sales Surtax Revenue and Expenditure report for the meeting on September 12, 2022.

As of July 31, 2022, the Village of Wellington collected \$3,996,497 in Surtax revenues on a \$4,720,909 budget or approximately 85% of budgeted revenues. Since inception, Wellington has collected \$25,248,790 in Surtax revenues.

The capital expenditures for the period ended July 31, 2022 are outlined below for each surtax project with project budget and prior year expenditures.

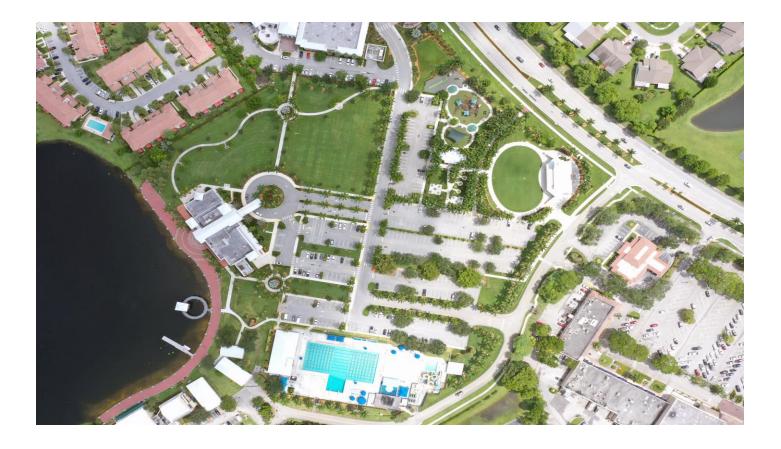

- Greenview Shores Park (aka WCHS project) has incurred a total of \$13,275,097 in project costs. Village Council awarded contracts totaling \$12,212,904 to Kaufman Lynn and Kimley Horn for construction and construction administration. These funds were encumbered in May 2020. The Phase I stadium field is completed. The Phase II track & field and batting cages are completed. The Phase III maintenance building, basketball courts and concession building are completed. The Grand Opening was on June 16, 2021 at the beautiful new complex! Additional expenses included softball batting cages and field equipment.
- Town Center Phase II: Village Council approved the Kaufman Lynn Construction Inc. contract for Phase II construction February 22, 2022 with an estimated cost of \$8,283,733. Phase II construction of the north parking is scheduled for completion in September 2022. The second part of Phase II began in June 2022 with the construction of the Amphitheater and Scott's Place expansion with an anticipated completion date of April 2023.
- The proposed Fiscal Year 2023 Budget includes the following Sales Surtax Projects and Funding:
