R2022-61** 2 3 A RESOLUTION OF WELLINGTON, FLORIDA'S COUNCIL AUTHORIZING THE MAYOR AND CLERK TO EXECUTE 4 AN AGREEMENT WITH PALM BEACH COUNTY FOR THE 5 USE OF THE WELLINGTON COMMUNITY CENTER FOR A 6 7 CONGREGATE DINING SITE; AND PROVIDING AN 8 **EFFECTIVE DATE.** 9 10 11 WHEREAS, Section 163.01, Florida Statutes, known as the "Florida Interlocal 12 Cooperation Act of 1969", authorizes local governments to make the most efficient use 13 of their powers by enabling them to cooperate with other localities on the basis of 14 mutual advantage and thereby provide services and facilities that will harmonize 15 geographic, economic, population and other factors influencing the needs and development of local communities; and 16 17 18 WHEREAS, Palm Beach County and Wellington recognize the need and benefit 19 of providing a space within the Wellington Community Center located at 12150 Forest 20 Hill Boulevard, Wellington, Florida 33414 for use as a congregate dining site and to 21 provide meal site staff; and 22 23 WHEREAS, the Agreement provides for a term of three (3) years, commencing 24 on the effective date, and continuing for three (3) years thereafter, unless sooner 25 terminated as provided for herein; and 26 27 WHEREAS, the Agreement also provides for an automatic renewal term of two 28 (2) additional, consecutive terms of one (1) year each ("Renewal Term"), with no 29 renewal term extending beyond five (5) years from the effective date; and 30 31 WHEREAS, Staff recommends that the Village Council approve the Use of 32 Facility Agreement for Government Entities, as presented; and 33 34 WHEREAS, the Agreement, attached as Exhibit "A", provides a mechanism for 35 providing this shared use; and 36 37 38 NOW, THEREFORE, BE IT RESOLVED BY WELLINGTON, FLORIDA'S 39 **COUNCIL** that: 40

SECTION 2. The Wellington Council hereby approves the Use of Facility Agreement for Government Entities with Palm Beach County (attached hereto as Exhibit "A") and hereby authorizes the Mayor and Clerk to execute the Agreement.
