Pursuant to the foregoing notice, a Regular Meeting of the Wellington Council was held on Wednesday, September 21, 2022, commencing at 7:00 p.m. at Wellington Village Hall, 12300 Forest Hill Boulevard, Wellington, FL 33414.

- 1. CALL TO ORDER Mayor Gerwig called the meeting to order at 7:00 p.m.
- 2. PLEDGE OF ALLEGIANCE Mayor Gerwig led the Pledge of Allegiance.
- **3. INVOCATION** Deacon Vince Muller, St. Therese de Lisieux Catholic Church, delivered the invocation.

#### 4. APPROVAL OF AGENDA

Mr. Barnes indicated staff recommended approval of the Agenda as presented.

A motion was made by Councilman McGovern, seconded by Councilman Napoleone, and unanimously passed (5-0), to approve the Agenda as presented.

## Public Comment:

1. Diane Gutman spoke regarding Consent Agenda Item 6C, Resolution No. R2022-61. She discussed the partnership between Wellington Cares and the Village of Wellington.

Mr. Barnes indicated staff recommended approval of the Consent Agenda as presented.

A motion was made by Councilman Napoleone, seconded by Councilwoman Siskind, and unanimously passed (5-0), to approve the Consent Agenda as presented.

## 7. PUBLIC HEARINGS

A. 22-5170

SECOND PUBLIC HEARING TO ADOPT THE FY 2022/2023 MILLAGE RATE AND ANNUAL BUDGET FOR WELLINGTON

I. RESOLUTION NO. R2022-59 (MILLAGE RATE)

A RESOLUTION OF WELLINGTON, FLORIDA'S COUNCIL ADOPTING THE TAX LEVY AND MILLAGE RATE FOR WELLINGTON FOR THE FISCAL YEAR COMMENCING OCTOBER 1, 2022 AND ENDING SEPTEMBER 30, 2023; AND PROVIDING AN EFFECTIVE DATE.

II. RESOLUTION NO. R2022-60 (WELLINGTON BUDGET)

A RESOLUTION OF WELLINGTON, FLORIDA'S COUNCIL ADOPTING A BUDGET FOR THE VILLAGE OF WELLINGTON FOR THE FISCAL YEAR COMMENCING OCTOBER 1, 2022 AND ENDING SEPTEMBER 30, 2023; AND PROVIDING AN EFFECTIVE DATE.

Ms. Quickel introduced and presented this item.

Ms. Addie read the Resolutions by title.

Ms. Quickel indicated this is the second Public Hearing on the tentative millage and budget adoption for the Fiscal Year (FY) 2023 budget.

Ms. Quickel stated the proposed FY 2023 millage rate is 2.47 mills, which represents the fourth year of a stable millage rate. She discussed the budget objectives, millage, revenues, millage rate impacts, TRIM values and sample properties. Ms. Quickel discussed the change in Wellington values for actual properties from FY 2021 to FY 2022. She stated there is a range of tax impacts on various assessed values for both homesteaded and non-homesteaded properties. Therefore, while the millage rate is unchanged, homeowners may see an increase in their taxes if their property value increases. She indicated 17% of the total tax bill goes to Wellington and ACME. Ms. Quickel discussed expenditures and ad valorem taxes. She stated the FY 2023 Proposed Budget is \$128.5 million. This is a decrease of \$5.4 million from FY 2022 due to a decrease in capital projects. Ms. Quickel reviewed budget survey results and highlighted the FY 2023 revenues and expenditures, Capital Projects/Programs, and projected fund balances. She stated Wellington is thriving as a Great Hometown.

# **Public Hearing**

A motion was made by Councilman Napoleone, seconded by Councilwoman Siskind, and unanimously passed (5-0), to open the Public Hearing.

There being no public comments, a motion was made by Councilman Napoleone, seconded by Councilwoman Siskind, and unanimously passed (5-0), to close the Public Hearing.

The Village Council provided comments regarding the millage and budget.

The Village Council commended Ms. Quickel and team on the budget.

Ms. Quickel read the mandatory budget language into the record.

A motion was made by Councilman McGovern, seconded by Councilwoman Siskind, and unanimously passed (5-0), to approve Resolution No. R2022-59 (Millage Rate) adopting the tax levy and millage rate for the Village of Wellington for the fiscal year commencing October 1, 2022 at 2.47 mills.

A motion was made by Councilman McGovern, seconded by Councilwoman Siskind, and unanimously passed (5-0), to approve Resolution No. R2022-60 (Wellington Budget) adopting the budget for the Village of Wellington for FY 2022/2023.

Mr. Barnes introduced this item.

Ms. Addie read the Ordinance by title.

Mr. Stillings stated this is the annual update to the Comprehensive Plan. The Village is required to do this each year following the adoption of the capital budget to incorporate the updated schedule of projects. In addition, it incorporates the school district reference for their fiscal year budget. Staff recommends approval as presented.

Vice Mayor McGovern indicated this is ministerial.

Mr. Stillings stated that is correct.

## Public Hearing

A motion was made by Councilman Napoleone, seconded by Councilman McGovern, and unanimously passed (5-0) to open the public hearing.

There being no public comments, a motion was made by Councilman Napoleone, seconded by Vice Mayor Drahos, and unanimously passed (5-0) to close the public hearing.

A motion was made by Councilman McGovern, seconded by Vice Mayor Drahos, and unanimously passed (5-0) to approve Ordinance No. 2022-29 (FY 2022/2023 Annual Capital Improvement Element Update of Wellington's Comprehensive Plan) as presented on first reading.

Mr. Barnes introduced the item. He recommended that there be one concurrent staff and corresponding presentation since the items (Ordinance No. 2022-26, Ordinance No. 2022-27 and Ordinance No. 2022-28) are related; with a separate motion for each item.

Ms. Addie read the Ordinances by title.

At this time, Ms. Cohen administered the oath to those individuals who wished to speak on the Items.

## **Ex-parte Communications**

**Councilman Napoleone:** Councilman Napoleone disclosed he had no ex-parte communications other than speaking with staff.

Vice Mayor Drahos: Vice Mayor Drahos disclosed he had no ex-parte communications.

**Mayor Gerwig:** Mayor Gerwig disclosed she had general conversations with the Lotis Development but nothing specific to these items.

**Councilman McGovern:** Councilman McGovern disclosed he had no ex-parte communications specific to these items tonight, but he has spoken with the representatives, Ms. Merchant, Mr. Markey and residents of Black Diamond on this subject. He stated he can be fair.

**Councilwoman Siskind:** Councilwoman Siskind disclosed she had no ex-parte communications other than speaking with staff.

Mr. Stillings introduced Damian Newell and presented the item. Mr. Stillings entered the files into the record. He stated this is a request by 441 Partners Inc., Four Four One Partners, Inc. and the Lake Worth Drainage District. The applicant is Lotis Wellington, LLC. and JKM Acquisitions, LLC. He stated Mr. Brian Terry, Agent/Insite Studio, Inc. was present on behalf of the applicant to answer any questions from Council. Mr. Stillings provided the background/update regarding the request. He showed Council a location map of the three parcels that are part of the annexation. He stated this is a voluntary annexation and is consistent with the statutory requirements of Chapter 171 Florida Statutes. He explained the second request (Comprehensive Plan Amendment) and the third request (Rezoning). He showed Council a graphic of Wellington's FLUM and Official Zoning Map. Mr. Stillings discussed the summary of findings. The Planning, Zoning and Adjustment Board (PZAB) recommended approval of these items at their August meeting. Staff recommends approval as presented.

Mr. Terry conducted his presentation. He showed Council a map of the Wellington Municipal Boundary and the Site Location. He discussed their requests and showed a graphic of the Conceptual Master Plan, Cross Access and Connectivity, Traffic Letters, Market Demand and referenced staff's recommendation of approval.

Mr. Barnes stated staff has received concerns that pertain to Lotis 1 and the property line from Wellington's Edge to Lotis I.

Mayor Gerwig commented regarding the drainage remaining where it is.

Councilman McGovern commented that there have been concerns from residents of Wellington's Edge and Black Diamond and encouraged them to continue to communicate with those residents.

Councilman Napoleone stated Council is allowing the property to come into Wellington tonight not approving the conceptual master plan.

Vice Mayor Drahos stated there is a tremendous amount of community interest in this project and residents need to be reassured that communication between the developer and staff has been excellent. Things are proceeding smoothly.

Councilwoman Siskind thanked Mr. Terry for keeping Council informed regarding the project.

# Public Hearing

A motion was made by Councilman Napoleone, seconded by Vice Mayor Drahos, and unanimously passed (5-0) to open the public hearing.

#### **Public Comment:**

1. Armando Gonzalez, President of Wellington's Edge, stated he has not had any contact with Mr. Terry since the beginning. He said residents are concerned.

Mr. Barnes stated staff will arrange a meeting with Wellington Edge residents.

2. Noel Chessman, a resident and board member of Black Diamond, stated he would like to participate in any meetings regarding this project. He commended the Village on the budget presentation.

There being no further public comments, a motion was made by Councilman Napoleone, seconded by Councilman McGovern, and unanimously passed (5-0) to close the public hearing.

A motion was made by Vice Mayor Drahos, seconded by Councilman McGovern, and unanimously passed (5-0) to approve Ordinance No. 2022-26 (LOTIS II ANNEXATION) as presented on second reading.

#### 8. REGULAR AGENDA

A. 22-5282 AUTHORIZATION TO RENEW A CONTRACT TO PROVIDE GENERAL LIABILITY, PROPERTY, CASUALTY AND WORKERS' COMPENSATION INSURANCE

Mr. Barnes introduced the item.

Mayor Gerwig disclosed a conflict of interest, passed the gavel to Vice Mayor Drahos and left the dais.

Mr. De La Vega stated this an annual contract expires on September 30, 2022. He said it is for general liability, property and casualty and worker's compensation. The contract is with the Florida Municipal Insurance Trust (FMIT). The proposal shows a decrease of \$171,104 less than the FY 2022 premium. The total cost is \$1,054,541.00. Mr. De La Vega stated this is the renewal. The Gehring Group, broker agent of record, solicited a quote from Preferred Government Insurance Trust and the quote was \$1,018,165 which was less than FMIT's proposal. He explained the reason for the staff's recommendation to renew with FMIT.

There was brief Council discussion with staff and the representative from The Gehring Group regarding the rates.

A motion was made by Councilman Napoleone, seconded by Councilwoman Siskind, and unanimously passed (4-0; with Mayor Gerwig recused) for Authorization to Renew a Contract with FMIT to provide Property, Casualty and Workers' Compensation Insurance Services for one more year through September 2023.

Mr. Barnes indicated there were no comment cards received.

MR. BARNES: Mr. Barnes presented the following report:

Next Council Meeting will be held on Tuesday, October 11, 2022 at 7:00 p.m.

#### **Events:**

Family Autofest – Wellington Rotary Club will host the 2nd Wellington Family Autofest on Sunday, October 2, 2022, from 9:30 a.m. to 1:30 p.m. at Village Park in the back-football parking lot area. The Autofest will feature classic cars and different types of vehicles along with children's activities, sponsors, vendors, and food trucks. All proceeds will go towards a different charity, selected by the Rotary Club, each month.

Public Safety Night – In partnership with the PBSO, PBCFR and other safety-minded organizations to join the Saturday evening concert (Hall and Oates tribute Band) and food truck series at Village Park. This event will feature touch-a-trucks (emergency vehicles), demonstrations, vendor information, and a special appearance from "Marshall and Chase", (as seen on Paw Patrol) on October 8, 2022 from 6:30 p.m. to 7:30 p.m.

Western Ride – This is a co-sponsored event with the Western Ride LLC (organized through resident Stephen Levin) to host the first "Western Ride" bicycle ride throughout Wellington on Sunday, October 9, 2022 from 6:00 a.m. to 12 noon. This ride features a 15-mile, 30 miles, and 60-mile course that will begin and end at Village Hall and travel throughout Wellington. PBSO will assist with safety for the bicyclists crossing major roadways and ICS Command Center will be set-up within Village Hall to monitor activity and ensure safety. There will be a ribbon cutting by Council and organizers at the start of the race (7:00 a.m.).

Fall Festival will be held on October 15, 2022 and bracelets are now on sale at Village Park and the Wellington Community Center. The theme this year is "Murder on the Bayou". The event will take place on November 5, 2022 from 5:30 p.m. to 9:00 p.m. at the Community Center.

# Planning:

Business walk and talks begin on October 24, 2022 and will run through November 16, 2022

SHIP applications will begin being accepted beginning in October.

The Affordable Housing Advisory Committee's (AHAC) first meeting has been tentatively scheduled for November.

# **Projects:**

Town Center: Construction is ongoing. Specifically, the contractor is working on getting the power completed for the initial phase parking area (FPL is there now) to get the lights turned on. Once power is completed (anticipated by Friday), we can schedule a final building inspection. Wrap is planned for the end of next week.

## Tennis:

USTA family championships are scheduled at the end of October. Junior tournaments and junior team tennis continue.

## **Public Safety/Emergency Management:**

On Tuesday, September 27, 2022 at 10:00 a.m., Village Emergency Management Officials in conjunction with South Florida Water Management District and Palm Beach County Fire Rescue will be hosting the "Community's Role in Flood Control" workshop. We invite local HOAs, Property Managers, and the public to join this FREE ZOOM seminar. Those interested in attending can join by going to the Village of Wellington's website.

Palm Beach County Fire Rescue is hosting a community-wide CPR and Stop the Bleed Training. This course is FREE and will be held on October 7, 2022 from 6:00 p.m. to 8:00 p.m. at the Wellington Community Center. Those interested can register in-person or online.

Starting next week, staff that has high interaction with the public will be trained by the Palm Beach County Behavioral Coalition on overdose prevention, recognition and response.

The Tropics are active and the State of Florida, Palm Beach County, and Village staff are closely monitoring the developments of invest 98L. As of Wednesday afternoon, most ensembles show timing of the system around Cuba next Tuesday. However, there is greater disagreement on the track later in the forecast period. Currently, there is no threat to Florida over the next 5 days. The Village is preparing and ready should we seen any potential impacts next week.

As we are in the peak months of Hurricane Season, it is a good reminder that September is National Preparedness Month. We encourage all residents that now is the time to review your family disaster plans and supplies. Check out the Village's Emergency Management page for official sources of information.
