4	APPROVING THE PUBLIC ASSEMBLIES
5	ADMINISTRATIVE POLICY TO PROVIDE FOR WAIVER OF
6	CERTAIN REQUIREMENTS, FEES, INSURANCE,
7	APPLICATION REVIEW, AND FAST-BREAKING
8	ASSEMBLY LOCATIONS; ADOPTING A FEE FOR PUBLIC
9	ASSEMBLY APPLICATIONS; AND PROVIDING AN
10	EFFECTIVE DATE.

12	WHEREAS the Wallington Council recently repealed Chapter 54 of Wallington's
13 14	WHEREAS , the Wellington Council recently repealed Chapter 54 of Wellington's Code of Ordinances in its entirety and amended and renumbered it as Chapter 20, titled
14	"Streets, Sidewalks, and Other Public Places"; and
15 16	Streets, Sidewarks, and Other Fublic Flaces, and
10 17	WHEREAS, the amended and renumbered Chapter 20 created Article IV, "Public
18	Assemblies" (the "Public Assembly Regulations"); and
19	
20	WHEREAS, the purpose of the Public Assembly Regulations is to facilitate the
21	exercise of the constitutional rights of free speech and peaceful assembly on certain
22	Wellington property, while fostering Wellington's substantial and compelling interests of
23	protecting the public health and safety; and
24	
25	WHEREAS, in order to avoid permitting requirements for public assemblies that
26 27	improperly limit lawful public assemblies and speech, Wellington has established
27	reasonable time frames and requirements for fees and certain costs, adjusted for the size and complexity of the public assembly, to consider and respond to the request for a
28 29	permit, and provided for prompt notice and appeal rights if an application is denied; and
30	permit, and provided for prompt house and appear rights in an application is defined, and
31	WHEREAS, any authority given to Wellington administrative staff to interpret and
32	apply the Public Assembly Regulations has been constrained by the specific and neutral
33	criteria; and

35	WHEREAS, to administer the Public Assembly Regulations, the Wellington
36	Council desires to adopt the Policy Implementing Chapter 20, Article IV, "Public
37	Assemblies" of Wellington's Code of Ordinances (the "Public Assemblies Policy"),
38	attached as Exhibit A, and to adopt a fee for public assembly applications; and
39 40	WHEREAS, the Wellington Council finds that the provisions of this Resolution
40 41	are in the best interests of Wellington, its residents, taxpayers, and business
42	community.
