3	A RESOLUTION OF WELLINGTON, FLORIDA'S COUNCIL
4	RELATING TO THE CONSTRUCTION BOARD OF
5	ADJUSTMENT AND APPEALS; PROVIDING FOR POWERS
6	AND DUTIES, MEMBERSHIP, TERMS OF OFFICE,
7	QUALIFICATIONS, AND VOTING REQUIREMENTS; AND
8	PROVIDING AN EFFECTIVE DATE.
9 10	WHEREAS, in accordance with the Florida Building Code, and section 489.105,
10	Florida Statutes, Wellington created the Construction Board of Adjustments and
12	Appeals to act as the Local Construction Regulation Board; and
13	Appeale to dot do the Lobal Construction Regulation Deala, and
14	WHEREAS, the creation of the Construction Board of Adjustments and Appeals
15	is codified in Chapter 2 of Wellington's Code of Ordinances; and
16	
17	WHEREAS, Wellington has amended its Code of Ordinances to remove
18	outdated and unnecessary provisions and simplify the provisions set forth therein; and
19 20	WHEREAS the emended Code of Ordinances provides for the creation of the
20 21	WHEREAS , the amended Code of Ordinances provides for the creation of the Construction Board of Adjustments and Appeals but provides that the powers and
$\frac{21}{22}$	duties of the Board, and the number, qualifications, and terms of office of the members
23	thereof, shall be established by resolution; and

25	WHEREAS, the Wellington Council now desires to provide for the powers and
26	duties, membership, terms of office, qualifications, and voting requirements for the
27	Construction Board of Adjustments and Appeals pursuant to the amended Code of
28	Ordinances.

30 31	NOW, THEREFORE, BE IT RESOLVED BY WELLINGTON, FLORIDA'S COUNCIL that:
32	
33	SECTION 1. Powers and Duties. The Construction Board of Adjustments and
34	Appeals shall have the power to hear appeals of decisions and interpretations of the
35	Building Official and consider variances of the technical codes.
36	
37	SECTION 2. Membership; Terms of Office; Qualifications. The Construction
38	Board of Adjustments and Appeals shall consist of seven members. Appointments of
39 40	members shall be for a term of two years. Appointments shall be made by the Wellington Council consistent with Chapter 2. Article VI of the Code of Ordinances. The
40 41	Wellington Council consistent with Chapter 2, Article VI of the Code of Ordinances. The Board should be composed of individuals who agree to apply the technical codes, with
42	preference given to those with knowledge and experience in the fields of architecture,
43	engineering, construction, and building permitting and contracting.
44	
45	SECTION 3. Quorum and Required Vote. A quorum for the transaction of
46	business by the Construction Board of Adjustments and Appeals shall consist of four

1 members. The affirmative vote of a majority of those present shall be necessary to take 2 official action.

SECTION 4. Initial Composition of the Construction Board of Adjustments and Appeals. The initial Construction Board of Adjustments and Appeals shall be comprised of those members appointed by the Wellington Council at the June 14, 2022 Council meeting or thereafter. Such members shall serve on the Construction Board of Adjustments and Appeals through May 31, 2024 unless otherwise provided by Chapter 2, Article VI of the Code of Ordinances. Subsequent appointments to the Construction Board of Adjustments and Appeals shall be made by the Wellington Council consistent with Chapter 2, Article VI of the Code of Ordinances and this Resolution. **SECTION 5.** This Resolution shall become effective immediately upon adoption.
