16	WHEREAS, Wellington's Council, as the governing body of Wellington, Florida
17	pursuant to the authority in Chapter 163 and Chapter 166, Florida Statutes, and the Land
18	Development Regulations (LDR) is authorized and empowered to consider petitions
19	related to zoning and development orders; and

21	WHEREAS, the notice and hearing requirements, as provided in Article 5 of the
22	LDR, as adopted by Wellington, have been satisfied; and

24	WHEREAS, the current Wellington Future Land Use Map designation for the Palm
25 26	Beach Little Ranches East Subdivision is Residential B; and
27	WHEREAS, the current Wellington Zoning Map designation for the Palm Beach
28	Little Ranches East Subdivision is Planned Unit Development (PUD); and

30	WHEREAS, the subject parcel (977 Cindy Drive) is within the Palm Beach Little
31	Ranches East Subdivision, which is a part of the Wellington PUD, and is designated as
32	an Open Space and Recreation Area on the recorded Palm Beach Little Ranches Eas
33	Plat; and
34	WHEREAS the applicant is requesting to amond the Wellington DLD Moster Dlar
35 36	WHEREAS, the applicant is requesting to amend the Wellington PUD Master Plan by increasing the number of units within the Palm Beach Little Ranches East pod from 34
37	to 35 dwelling units, and approve site-specific development standards to allow for
38	development of the subject parcel as a single-family residential lot.; and

86 87 88 WHEREAS, The Council has made the following findings of fact:

- 1. The proposed amendment to add a single-family residential lot for the subject parcel within Wellington PUD Palm Beach Little Ranches East pod is not consistent with the characteristics and lot size of the Palm Beach Little Ranches East neighborhood as stated in Wellington's Comprehensive Plan future land use map designation or the Palm Beach Little Ranches Overlay Zoning District.
- 2. The proposed amendment and site-specific development standards are not be compatible with the Palm Beach Little Ranches neighborhood and is not consistent with the stated purposes and intent. Palm Beach Little Ranches was developed as a residential equestrian neighborhood with platted lot size from two (2) to 10 acres.
- The subject parcel shall remain an Open Space and Recreation Area as designated on the Palm Beach Little Ranches East of Wellington Plat.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF WELLINGTON, FLORIDA, THAT:

SECTION 1. The request to amend the Wellington PUD Master Plan to add one (1) dwelling unit and allow site-specific development standards for development of the subject parcel (977 Cindy Drive), as legally described in Exhibit A, is hereby denied and the site shall remain Open Space and Recreation Area as designated on the Palm Beach Little Ranches East Plat.

SECTION 2: Should any section, paragraph, sentence, clause, or phrase of this Resolution conflict with any section, paragraph, clause or phrase of any prior Ordinance, Resolution, or municipal Code provision, then in that event the provisions of this Resolution shall prevail to the extent of such conflict.

SECTION 3: Should any section paragraph, sentence, clause, or phrase of this Resolution be declared by a court of competent jurisdiction to be invalid, such decision shall not affect the validity of this Resolution as a whole or any portion or part thereof. other than the part to be declared invalid.

SECTION 4: This Resolution shall become effective immediately upon approval.
