A RESOLUTION OF THE ARCHITECTURAL REVIEW BOARD OF THE VILLAGE OF WELLINGTON, FLORIDA, AMENDING THE ARB APPROVED COLOR CHART BY ADDING SPRITE TWIST (PPG1226-3) AS A PRIMARY EXTERIOR COLOR; AND PROVIDING AN EFFECTIVE DATE.		
<b>WHEREAS,</b> the Architectural Review Board, pursuant to Resolution No. R2022-21 is tasked with adopting by resolution various scheduled of approved materials, designs, and charts of approved colors; and		
<b>WHEREAS,</b> pursuant to sections 125.571 and 166.0483, <i>Florida Statutes</i> , a loca government may not require an owner of a residence to obtain a permit to paint such residence; and		
WHEREAS, nothing in the foregoing statutes prohibits Wellington from requiring owners to adhere to the Architectural Review Board approved color chart; and		
WHEREAS, it is the responsibility of all property owners to ensure that the color used to paint or repaint their homes match the approved color chart prior to painting; and		
WHEREAS, Code Compliance will actively monitor colors used within the Village and		
<b>WHEREAS,</b> if a color is not on the adopted color chart, a property owner may see a legislative change to the approved color chart to add a desired color and such change, approved, will apply Village-wide.		
NOW, THEREFORE, BE IT RESOLVED BY THE ARCHITECTURAL REVIEW BOARD OF THE VILLAGE OF WELLINGTON, FLORIDA, THAT:		
<b>SECTION 1.</b> The ARB color chart is hereby amended by adding Sprite Twis (PPG1226-3) as a primary exterior color and shall be available in the Planning, Zoning, and Building Department during normal hours of operation for review and comparison.		
<b>SECTION 2.</b> In the event an applicant desires to request a modification to the color chart, the applicant shall complete an application, on a form provided by the PZE Department, and submit all required information, along with the required fee, fo consideration by the Architectural Review Board.		
<b>SECTION 3.</b> This resolution shall take effect immediately upon its adoption.
