EASEMENT AGREEMENT

20' CANAL ACCESS EASEMENT

This Easement Agreement (this “**Easement**”) is made as of the _____ day of May 2023, by, ACME IMPROVEMENT DISTRICT, A DEPENDENT SPECIAL DISTRICT OF THE VILLAGE OF WELLINGTON, FLORIDA, A MUNICIPAL CORPORATION OF THE STATE OF FLORIDA, having an address at 12300 Forest Hill Boulevard, Wellington, FL 33414 (“**Grantor**”) in favor of FAR NIENTE STABLES I, LLC, A FLORIDA LIMITED LIABILITY COMPANY (“**Far Niente**”) and **WELLINGTON CYPRESS GOLF, LLC**, A Florida limited liability company (“**Wellington Cypress Golf**”) (Far Niente and Wellington Cypress Golf are collectively, “**Grantee**”), having an address at 13421 South Shore Boulevard, Suite 10, Wellington, Florida 33414.

RECITALS

WHEREAS, Far Niente is the owner of the certain parcel of real estate more particularly described on **Exhibit “A-1”** attached hereto and made a part hereof and Wellington Cypress Golf is the owner of those certain parcels of real estate more particularly described on **Exhibit “A-2”** attached hereto and made a part hereof (the lands depicted on Exhibit A-1 and Exhibit A-2 shall be collectively described as the “**Grantee Lands**”); and

WHEREAS, Grantor is the owner of that certain canal commonly known as the “C-6 Canal which lies adjacent to the Grantee Lands (the “**Canal**”); and

WHEREAS, the Grantor has agreed to grant to Grantee an easement on, and over, that certain portion of the Canal, as legally described in **Exhibit “B”** attached hereto and made a part hereof (the “**Canal Access Easement**”), under the terms and conditions set forth herein.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor and Grantee hereby agree as follows:

1. **Grant.** Grantor hereby grants to Grantee and all subsequent owners of the Grantee Lands a non-exclusive, perpetual easement over the Canal Access Easement, appurtenant to and for the benefit of the Grantee Lands, for the purpose of permitting Grantee to install, construct and maintain a multi modal path (including bicycle, pedestrian, golf carts and maintenance equipment) and permitting Grantee and all subsequent owners of the Grantee Lands and their employees, agents, contractors, subcontractors, licensees, permittees, guests and all other invitees of Grantee to use the Canal Access Easement for multi modal access for the Grantee Lands, which may now or hereafter be developed on the Grantee Lands.

2. **Non-Exclusivity.** Grantee hereby acknowledges that the Canal Access Easement granted herein is non-exclusive and Grantee's use of the Canal Access Easement shall be in common with Grantor's continuing operation and use of the Canal.

3. **Improvements.** Upon receipt of Grantor's prior written approval, Grantee shall be entitled to construct a multi modal path, including installation of related drainage facilities, landscaping and utilities and certain improvements over the Canal Access Easement. Grantee shall repair and maintain, at its sole cost and expense, any such improvements within the Canal Access Easement.

4. **Hold Harmless.** Grantee shall indemnify, defend and hold harmless, to the maximum extent permitted by law, GRANTOR, its agents, officers, employees and representatives, from and against any and all liability, suits, actions, proceedings, judgments, claims, losses, liens, damages, injuries (whether in contract or in tort, including personal injury, accidental death or property damage, and regardless of whether the allegations are false, fraudulent or groundless), costs and expenses (including attorneys' fees, litigation, arbitration, mediation, appeal expenses) which in whole or in part arise out of or are connected with, or which are alleged to have arisen out of or to have been connected with the construction of and existence of the Structures in the Easement Area, and any subsequent maintenance and repairs to the Structures in the Easement Area.

Grantee further holds Grantor and/or the Village of Wellington (collectively, "**Village Parties**") harmless for any and all damages to the improvements and/or facilities (collectively "**Structures**") located in the Easement Area as a result of any work, construction or repairs the Village Parties may perform within the Easement Area and agrees that all costs to repair or replace the Structures shall be the sole expense of the Grantee. Nothing set forth herein shall constitute a waiver of the Village Parties sovereign immunity protections and the limitations set forth in Section 768.28, Florida Statutes. Nothing contained in this Agreement shall create a contractual relationship with or a cause of action in favor of a third party against either Village Parties or the Grantee.

5. **Non-Interference.** No activities or improvements made by the Grantee shall interfere with the rights and activities of Village Parties and/or their staff, employees or agents to maintain the required permit obligations/conditions of the area generally referred to as "the Big Blue Preserve" or any other works or activities of the Village Parties.

6. **Standards.** Any improvements made to the Canal crossing by the Grantee, shall meet all Village Parties standards.

7. **Maintenance.** Any improvements made to the Canal crossing and/or easement shall be maintained in perpetuity by the Grantee. If at any time, the improvements are found by the Village Parties to have fallen into disrepair or are determined to be a hazard to life, health, or safety, the Village Parties reserve all rights to remove and/or repair all improvements or modifications to the canal crossing and/or easement. The Grantor also reserves the right to restrict access to the Canal Access Easement until timely repairs can be made by the Grantee.

8. This Easement shall run with the land and shall bind and inure to the benefit of the parties hereto and their respective successors and assigns.

9. Grantor hereby reserves all rights with respect to the Canal Access Easement not specifically granted by this Easement.

10. This Easement shall be governed by and construed in accordance with the laws of the State of Florida.


