16 17	R2007-47 the Joint Participation Agreement and the Maintenance Memorandum of Agreement between the Village of Wellington and State of Florida Department of
17	Transportation (Exhibit B – Resolution R2007-47).

20	WHEREAS, the State of Florida Department of Transportation requires the
21 22	Village of Wellington to enter into an Amendment 1 to Landscape Maintenance Memorandum of Agreement (Exhibit C – FDOT Amendment 1 to LMMOA); and
22	Memorandum of Agreement (Exhibit C – PDOT Amendment 1 to EmmoA), and
24	WHEREAS, WRMC has agreed to install the landscaping and agreed to be
25	responsible for the maintenance thereof; and
26 27	WHEREAS, an Agreement has been prepared setting forth the parties'
28	obligations and is attached hereto (Exhibit D – WRMC Landscape Maintenance
29	Agreement).

31 32	NOW, THEREFORE, BE IT RESOLVED BY WELLINGTON, FLORIDA'S COUNCIL that:

34	SECTION 1. The foregoing recitals are hereby affirmed and ratified as being true
35	and correct.
36 37	SECTION 2. The Village Council hereby accepts and approves the Agreement
38	among WRMC and the Village of Wellington and hereby authorizes the Mayor and
39	Village Clerk to execute such Agreement.
