

NOTICE OF ADOPTION

RESOLUTION NO. R2017-15

THE WELLINGTON COUNCIL PURSUANT TO THE AUTHORITY PROVIDED IN THE CODE OF ORDINANCES CHAPTER 54, DIVISION 2, KNOWN AS THE WELLINGTON VACATING AND ABANDONMENT ORDINANCE, DID HOLD A MEETING ON APRIL 25, 2017 PERTAINING TO RESOLUTION NO. R2017-15, TO VACATE, ABANDON, DISCONTINUE AND CLOSE AN 18 FOOT PORTION OF A 25-FOOT MAINTENANCE EASEMENT LEGALLY DESCRIBED AS FOLLOWS:

BEING A PORTION OF LOT 22, BLOCK 29, SUGAR POND MANOR OF WELLINGTON, PUD, ACCORDING TO THE PLAT THEREOF, AS RECORDED IN PLAT BOOK 30, PAGE 20 OF THE PUBLIC RECORDS OF PALM BEACH COUNTY, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE MOST SOUTHERLY CORNER OF SAID LOT 22; THENCE N51°53'05"E WITH THE SOUTHEASTERLY LINE OF SAID LOT 22 FOR A DISTANCE OF 7.00 FEET TO THE POINT OF BEGINNING; THENCE CONTINUE N51°53'05"E WITH THE SOUTHEASTERLY LINE OF SAID LOT 22 FOR A DISTANCE OF 18.00 FEET TO A POINT ON A NON-TANGENT CURVE TO THE LEFT HAVING A RADIUS OF 430.53' AND WHOSE CHORD BEARS N43°00'43"W FOR A DISTANCE OF 73.50'; THENCE NORTHWESTERLY WITH SAID CURVE THROUGH A CENTRAL ANGLE OF 9°47'36" FOR AN ARC LENGTH OF 73.59' TO A POINT IN THE NORTHWESTERLY LINE OF SAID LOT 22; THENCE S42°05'29"W WITH THE NORTHWESTERLY LINE OF SAID LOT 22 FOR A DISTANCE OF 18.00 FEET TO A POINT ON A NON-TANGENT CURVE TO THE RIGHT HAVING A RADIUS OF 412.53 FEET AND WHOSE CHORD BEARS S43°00'43"E FOR A DISTANCE OF 70.43 FEET; THENCE SOUTHEASTERLY ALONG

SAID CURVE TO THE RIGHT THROUGH A CENTRAL ANGLE OF 9°47'36" FOR AN ARC
LENGTH OF 70.43 FEET TO THE POINT OF BEGINNING
