R2017-40** 2 3 A RESOLUTION OF WELLINGTON, FLORIDA'S COUNCIL, 4 ADOPTING THE DEVELOPMENT REVIEW MANUAL, AS MORE 5 SPECIFICALLY DESCRIBED HEREIN, TO PROVIDE FORMS 6 PLANNING AND ZONING APPLICATION 7 SUBMITTAL REQUIREMENTS, REVIEW CRITERIA AND DETAIL 8 THE PROCESS FOR DEVELOPMENT APPLICATIONS AS 9 ARTICLE 5 OF WELLINGTON'S LAND REQUIRED IN 10 DEVELOPMENT REGULATIONS AND TO COMPLY WITH FLORIDA STATUTES: PROVIDING A CONFLICTS CLAUSE: 11 12 PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN 13 **EFFECTIVE DATE.** 14 15 WHEREAS, the Council, as the governing body of the Village of Wellington, 16 Florida, pursuant to the authority in Chapter 163 and Chapter 166, Florida Statutes, and 17 18 the Land Development Regulation is authorized and empowered to consider petitions 19 related to zoning and development orders; and 20 21 WHEREAS, the notice and hearing requirements, as provided in Article 5 of the 22 Land Development Regulation, as adopted by Wellington, have been satisfied; and 23 24 WHEREAS, Article 5 of the Land Development Regulations provides that a 25 Development Review Manual shall be adopted by the Village Council; and 26 27 WHEREAS, the Development Review Manual shall provide forms for planning 28 and zoning application types, submittal requirements, review criteria and detail the 29 process for development applications required for all development orders; and 30 31 WHEREAS, the Planning, Zoning and Adjustment Board, sitting as the Local 32 Planning Agency, after notice and public hearing on August 9, 2017, recommended \_\_\_\_\_ of the Development Review Manual with a \_\_\_\_\_ vote; and 33 34 35 WHEREAS, the Council has taken the recommendations from the Local Planning Agency, Equestrian Preserve Committee, Wellington staff and the comments from the 36 37 public into consideration when considering the proposed Development Review Manual 38 (Exhibit A); and 39 40 **WHEREAS.** The Council has made the following findings of fact: 41 42 1. The Development Review Manual is consistent with the Comprehensive Plan; 43 2. The Development Review Manual is consistent with the Land Development 44 45 Regulations; 46

- 3. The Development Review Manual furthers the overall Village goal to streamline the development review process and be user friendly; and
- 4. The Development Review Manual will become an official document of the Planning, Zoning and Building Department.

## NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF WELLINGTON, FLORIDA, THAT:

**SECTION 1.** The Development Review Manual is hereby adopted as provided for in Exhibit A of this resolution.

**SECTION 2:** All development applications shall be processed in compliance with the Development Review Manual.

<u>SECTION 2:</u> The Development Review Manual shall not be modified without Council approval, unless modifications to the manual are required as a result of changes to Florida Statutes.

**SECTION 3:** Should any section, paragraph, sentence, clause, or phrase of this resolution conflict with any section, paragraph, clause or phrase of any prior Wellington Ordinance, Resolution, or Municipal Code provision, in that event the provisions of this resolution shall prevail to the extent of such conflict.

**SECTION 4:** Should any section, paragraph, sentence, clause, or phase of this resolution be declared by a court of competent jurisdiction to be invalid, such decision shall not affect the validity of this resolution as a whole or any portion of part thereof, other than the part so declared to be invalid.

**SECTION 5:** This resolution shall become effective upon the approval of the companion Zoning Text Amendment (Ordinance No. 2017-11) to repeal and replace Article 5 of the Land Development Regulations.
