R2017-40** 2 3 A RESOLUTION OF WELLINGTON, FLORIDA'S COUNCIL, 4 ADOPTING THE DEVELOPMENT REVIEW MANUAL, AS MORE 5 SPECIFICALLY DESCRIBED HEREIN, TO PROVIDE FORMS 6 PLANNING AND ZONING APPLICATION 7 SUBMITTAL REQUIREMENTS, REVIEW CRITERIA AND DETAIL 8 THE PROCESS FOR DEVELOPMENT APPLICATIONS AS ARTICLE 9 REQUIRED IN 5 OF WELLINGTON'S LAND 10 DEVELOPMENT REGULATIONS AND TO COMPLY WITH FLORIDA STATUTES. 11 12 13 14 WHEREAS, the Village of Wellington's Council, as the governing body of the Village of Wellington, Florida, pursuant to the authority in Chapters 163 and 166, Florida 15 16 Statutes, and the Land Development Regulations is authorized and empowered to 17 consider petitions related to zoning and development orders; and 18 19 WHEREAS, the notice and hearing requirements, as provided in Article 5 of the 20 Land Development Regulations, as adopted by Wellington, have been satisfied; and 21 22 WHEREAS, Article 5 of the Land Development Regulations provides that a 23 Development Review Manual shall be adopted by the Village Council; and 24 25 WHEREAS, the Development Review Manual shall provide forms for planning 26 and zoning application types, submittal requirements, review criteria and detail the 27 process for development applications required for all development orders; and 28 29 WHEREAS, the Planning, Zoning and Adjustment Board, sitting as the Local 30 Planning Agency, after notice and public hearing on August 9, 2017, recommended of the Development Review Manual with a vote; and 31 32 33 WHEREAS, the Council has taken the recommendations from the Local Planning 34 Agency, Equestrian Preserve Committee, Wellington staff and the comments from the 35 public into consideration when considering the proposed Development Review Manual (Exhibit A); and 36 37 38 WHEREAS, The Council has made the following findings of fact: 39 40 1. The Development Review Manual is consistent with the Comprehensive Plan: 41 42 2. The Development Review Manual is consistent with the Land Development Regulations; 43 44 45 The Development Review Manual furthers the overall Village goal to streamline 46 the development review process and be user friendly; and
