**A RESOLUTION OF WELLINGTON, FLORIDA'S COUNCIL  
APPROVING AND AUTHORIZING THE MANAGER OR  
DESIGNEE TO EXECUTE THE CONTRACT WITH THE  
FLORIDA DEPARTMENT OF CORRECTIONS TO PROVIDE  
FOR THE USE OF INMATE LABOR IN WORK PROGRAMS  
WITHIN THE WELLINGTON ENVIRONMENTAL PRESERVE  
AT THE MARJORY STONEMAN DOUGLAS EVERGLADES  
HABITAT; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the Florida Department of Corrections and Wellington have negotiated a contract for the use of inmate labor for the maintenance of the Wellington Environmental Preserve at the Marjory Stoneman Douglas Everglades Habitat; and

**WHEREAS**, said Contract provides for a term of one (1) year; this being the final renewal year of the contract; and

**WHEREAS**, under the terms of the Contract it is anticipated that the Department of Corrections will be paid \$57,497.00 annually for the guard and work squad; and

**WHEREAS**, Council approved entering into the renewal of the previous contract through Amendment #1 and Resolution R2016-59; and

**WHEREAS**, Staff recommends that the Contract between Wellington and the Florida Department of Corrections be approved for a period of one (1) year expiring on January 6, 2019; and

**NOW, THEREFORE, BE IT RESOLVED BY WELLINGTON, FLORIDA'S COUNCIL** that:

**SECTION 1.** The foregoing recitals are hereby affirmed and ratified as being true and correct.

**SECTION 2.** The Wellington Council hereby approves the Contract with the Florida Department of Corrections (attached hereto as Exhibit "A") and authorizes the Manager or his Designee to execute said agreement on behalf of Wellington.

**SECTION 3.** This Resolution shall become effective immediately upon adoption.
