13	WHEREAS, Section 163.01, Florida Statutes, known as the "Florida Interlocal		
14	Cooperation Act of 1969,: authorizes local governments to make the most efficient use		
15	of their powers by enabling them to cooperate with other localities on a basis of mutual		
16 17	advantage and thereby to provide services and facilities that will harmonize geographic,		
17 18	economic, population and other factors influencing the needs and development of local		
18 19	communities; and		
19 20	WHEREAS, the Drowning Prevention Coalition of Palm Beach County was		
20 21	created to generate public awareness of the danger of childhood drowning and		
22	implement a water safety program to reduce drowning incidents; and		
23	implement a water earery program to reduce alevining melaente, and		
24	WHEREAS, the Drowning Prevention Coalition of Palm Beach County has		
25	proposed an Interlocal Agreement with Wellington to provide for vouchers for free		
26	swimming lessons for those individuals under the "Buck" Program who may not		
27	otherwise have the ability to afford them; and

29	WHEREAS, Staff recommends that the Village Council approve the Interlocal		
30	Agreement with the Drowning Prevention Coalition of Palm Beach County; and

32	WHEREAS, such Interlocal Agreement has been prepared and a copy is		
33	attached hereto.
