14	WHEREAS, Wellington's Council previously adopted Rules of Procedures for Council
15	meetings through the passage of Resolution R2011-75; and
16	
17	WHEREAS, the Council desires to amend the Rules of Procedure in an effort to provide
18 19	more streamlined rules governing various Village meetings and to include (1) an express statement that the procedures apply to all boards and committees as well as council; (2) a
20	provision prohibiting remote attendance at quasi-judicial hearings; (3) clarification concerning
20	public comment for consent items; (4) inclusion of a public forum at both the beginning and
22	end of the meeting; (5) streamlined parliamentary rules governing debates and motions; and
23	(6) reordering of the invocation and Pledge of Allegiance.
