R2007-36 OF THE VILLAGE 5 COUNCIL OF THE VILLAGE OF WELLINGTON, FLORIDA AND 6 ADOPTING A NEW POLICY FOR THE INSTALLATION OF SPEED 7 **HUMPS WITHIN THE VILLAGE OF WELLINGTON; AND PROVIDING** 8 AN EFFECTIVE DATE. 9 10 WHEREAS, Resolution No. R2007-36 was adopted by the Village Council on March 20, 2007 to adopt the modified "Speed Hump Policy" and "Policy for Speed 11 12 Hump Installation within the Village of Wellington, Florida;" 13 14 WHEREAS, the Village Council recognizes that certain residential streets are 15 more impacted than others by cut through traffic and vehicular speeding; and 16 17 WHEREAS, the traditional traffic control measures have not always proven 18 effective in addressing such problems; and 19 20 WHEREAS, properly placed and designed speed humps have been used effectively in other cities in the United States and represent an innovative approach in 21 certain locations when installed under specific guidelines and design standards for 22 23 reducing vehicular speed and discouraging cut through traffic on residential streets; and 24 25 WHEREAS, the Village Council recognizes that such conditions may exist on 26 privately as well as publicly maintained streets. 27 NOW, THEREFORE, BE IT RESOLVED BY WELLINGTON, FLORIDA'S 28 **COUNCIL** that: 29 30 31 **SECTION 1.** The foregoing recitals are hereby affirmed and ratified as being true 32 and correct. 33 **SECTION 2.** The Policy for Speed Hump Installation within the Village of 34 35 Wellington, Florida adopted by Resolution No. R2007-36 is hereby repealed in its entirety and is of no further effect. 36 37 38 **SECTION 3.** Any speed hump approval granted under the terms of Resolution 39 No. R2007-36 remains valid. 40 SECTION 4. Wellington's Council hereby adopts the modified "Speed Hump 41 42 Policy" and "Policy for Speed Hump Installation Within the Village of Wellington, 43 Florida", dated March 27, 2018, a copy of which is attached hereto and made a part 44 hereof. 45
