R2018-16** 2 3 A RESOLUTION OF WELLINGTON, FLORIDA'S COUNCIL AMENDING THE CAPITAL AND GENERAL FUND BUDGET 4 FOR FISCAL YEAR 2018 BY TRANSFERRING MONIES 5 FROM NEIGHBORHOOD PARKS CAPITAL PROJECTS TO 6 7 OPERATING EXPENSE FOR NEIGHBORHOOD PARKS 8 RESURFACING; AND PROVIDING AN EFFECTIVE DATE. 9 10 WHEREAS, if approved by Council, the Village of Wellington will award a 11 12 contract for Neighborhood Park surface installation and repairs not to exceed \$240,871; 13 and 14 15 WHEREAS, this amount is included in the adopted Governmental Capital Fund budget for FY 2017-2018; however, due to the nature of the work at Tiger Shark Park 16 17 and Margate Park, needs to be included as part of the General Fund Operating budget 18 in order to comply with adopted accounting standards; and 19 20 WHEREAS, the current General Fund Operating budget does not include this 21 work and requires funds to be transferred from the Governmental Capital Fund budget 22 to the General Fund Operating budget; and 23 WHEREAS, the Governmental Capital Fund budget may be transferred to the 24 25 General Fund Operating budget by Village Council; and 26 27 WHEREAS, a Budget Amendment, attached as Exhibit "A", has been prepared in 28 accordance with Section 6 of Wellington's Charter and in compliance with §166.241 (4) 29 (c) Florida's Statutes and Article VII, Purchasing Contracts, and Property Management 30 Policies, Section 2-332 of Wellington's Code of Ordinances transferring \$100,000 from 31 Governmental Capital Improvement budget and appropriating the transferred funds for 32 General Fund operating expense; and 33 34 WHEREAS, Wellington's Manager recommends approval of the Budget 35 Amendment. 36 37 NOW, THEREFORE, BE IT RESOLVED BY WELLINGTON, FLORIDA'S 38 **COUNCIL** that: 39
