MORE ZONING **TEXT** 5 AMENDMENT TO REPEAL AND REPLACE ARTICLE 8, IN ITS 6 7 ENTIRETY AS CONTAINED HEREIN: TO ESTABLISH SPECIFIC STANDARDS RELATED TO SUBDIVISION, PLATTING, AND 8 IMPROVEMENTS: **PROVIDING** 9 Α CONFLICTS CLAUSE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING AN 10 **EFFECTIVE DATE.** 11 12 WHEREAS, the Village Council, Florida, as the governing body, pursuant to the 13 authority vested in Chapter 163, Chapter 166 and Chapter 177, Florida Statutes, is authorized 14 and empowered to consider changes to its Land Development Regulations (LDR); and 15 16 WHEREAS, upon incorporation in 1996, the Village elected to utilize the Palm Beach 17 County (PBC) Unified Land Development Code (ULDC), as the LDR for the Village of 18 Wellington; and 19 20 21 WHEREAS, over the years minor amendments to the LDR have been codified to address changed conditions or to modify the code to suit specific needs of the Village to 22 23 ensure the health, safety, welfare and overall quality of life; and 24 WHEREAS, Wellington believes that it is in the best interest of the community to make 25 additional modifications to the LDR to streamline the development review process, to 26 27 establish a process that best serves the public, and to create an incentive for betterment of future development and redevelopment; and 28 29 30 WHEREAS, The Planning, Zoning and Adjustment Board, acting as the Local Planning Agency, after notice and public hearing on April 11, 2018, has reviewed the proposed 31 Ordinance for consistency with Wellington's Comprehensive Plan and made a 32 recommendation for _____ with a ____ - ___ vote; and 33 34 WHEREAS, Village Council has taken the recommendations from the Local Planning 35 Agency, Wellington staff and the comments from the public into consideration as part of the 36 review of the proposed amendment to the LDR that are the subject of this Ordinance. 37 38 NOW THERFORE BE IT ORDAINED BY THE COUNCIL OF WELLINGTON, 39 FLORIDA THAT: 40 41 SECTION 1. Article 8 Subdivision, Platting and Required Improvements of the 42 43 Wellington Land Development Regulations, is hereby repealed and replaced in its entirety, as specifically provided for in Exhibit A of the Ordinance. 44 45
