- 8. This MOA shall go into effect on the date of final execution and remain in effect until either party, provides sixty (60) calendar days written notification, wishes that this MOA be dissolved.
- 9. This MOA shall be evaluated and appropriately revised at such time mutually agreed to by the signatories or as may be required from time to time by regulatory changes.

- 7. Landowners who choose not to enroll in the FDACS equine BMP program as described in this MOA shall be subject to Wellington's water quality and regulatory requirements addressing equine land uses occurring on the landowner's property.
- 8. Wellington agrees to provide agricultural landowners the opportunity to enroll in the FDACS BMP program and implement applicable BMPs as an option in any settlement agreements or resolution of violation agreements that arise as a result of investigation or enforcement action by Wellington on properties that meet agricultural land use classification requirements.

FDACS ADOPTED EQUINE BMP IMPLEMENTATION ASSURANCE

- FDACS and Wellington will jointly develop a schedule for Implementation Assurance visits of enrolled equine BMP landowners. Such schedule shall provide for an annual review, by Wellington staff, of the landowner's implemented BMPs as identified in the landowner's BMP enrollment documentation.
