SECTION 2. The Wellington Council hereby approves the Easement Agreement with the Florida Power and Light Company (FP&L) relating to the construction, operation and maintenance of one or more overhead and underground electric transmission and distribution lines, as attached hereto as "Exhibit A" and hereby authorizes the Manager or designee to execute the Agreement.
