3	A RESOLUTION OF WELLINGTON, FLORIDA'S COUNCIL
4	APPROVING A SEASONAL EQUESTRIAN USE PERMIT FOR THE
5	GLOBAL DRESSAGE COMPLEX, AKA EQUESTRIAN VILLAGE, AT
6	13466 SOUTH SHORE BOULEVARD FOR AN EQUESTRIAN SHOW
7	USE FROM DECEMBER 1, 2018 TO APRIL 30, 2019; AND
8	PROVIDING AN EFFECTIVE DATE.
9	WUEDEAS the evenera of the Clabel Dressage Complex, ske Equestrian
10	WHEREAS, the owners of the Global Dressage Complex, aka Equestrian
11	Village, is located at 13466 South Shore Boulevard, requested a seasonal equestrian
12 13	use permit for December 1, 2018 to April 30, 2019; and
15 14	WHEREAS, the 59.37 acre property located at the northeast corner of South
14	Shore Boulevard and Pierson Road is within Subarea D of the Equestrian Overlay
16	Zoning District (EOZD) and within the Wellington Planned Unit Development (PUD); and
17	Zening District (2020) and within the Weinington Filamica on Development (100), and
18	WHEREAS, the site has a Wellington Future Land Use Map designation of
19	Commercial Recreation; and
20	
21	WHEREAS, Wellington Council adopted Resolution No.R2013-49 designating
22	Equestrian Village as a Commercial Equestrian Arena with conditions that required on-
23	site and off-site improvements to be completed by December 2014; and
24	
25	WHEREAS, Equestrian Village exercised their right to a legislative extension of
26	development order conditions; and
27	
28	WHEREAS, in order to have beneficial use of the site for the 2018/2019
29	equestrian season is required by Wellington's Land Development regulations to obtain a
30	Seasonal Equestrian Permit in lieu of operating under the Commercial Equestrian
31	Arena; and
32	WUEDEAC Castion 5.2.0 of the Wallington Land Development Degulations
33	WHEREAS, Section 5.3.9 of the Wellington Land Development Regulations
34 35	requires that Equestrian Permits that exceed 30 event days within a six (6) month period are considered Seasonal Permits and require Council approval for the initial
35 36	request; and

38	WHEREAS, the site complies with the general standards in the Development
39	Review Manual for the Seasonal Equestrian Permit; and

41 42 43	WHEREAS, Wellington Council adopted Resolution No.R2017-57 for a Seasonal Equestrian Permit for the 2017/2018 season on November 14, 2017 which required Council approval of a request for a Seasonal Permit for the 2018/2019 Equestrian
44	Season if the required roadway improvements for the compatibility determination were
45	not completed. To date, roadway improvements have not been started; and
46	
47	WHEREAS, the applicant is seeking approval of a seasonal equestrian use
48	permit for the 2018/2019 season which has the same on-site intensity as the previous
49	year; and
50	
51	WHEREAS, the Wellington Council has considered the information presented by
52	the Petitioner and the recommendations of Wellington's Staff for the requested seasonal
53	equestrian special permit that is the subject of this resolution and with the limitations
54	and conditions a set forth in Exhibit A.
55	
56	NOW, THEREFORE, BE IT RESOLVED BY WELLINGTON, FLORIDA'S
57	COUNCIL THAT:

59	SECTION 1. The foregoing recitals are hereby affirmed and ratified.
60	
61	<u>SECTION 2.</u> The Wellington Council hereby approves the seasonal equestrian
62	use permit for the period of December 1, 2018 to April 30, 2019, attached as Exhibit A,
63 64	for the Global Dressage Complex, aka Equestrian Village, subject to the conditions of approval and related site plan.
65	approval and related site plan.
66	SECTION 3. This Resolution shall be effective immediately upon adoption.
