#### **RESOLUTION NO. R2019-01**

### A RESOLUTION OF WELLINGTON, FLORIDA'S COUNCIL AMENDING THE FISCAL YEAR 2018-2019 ROAD IMPACT FUND BUDGET AND THE GOVERNEMTAL CAPITAL FUND BUDGET TO ASSIGN FUNDS FOR THE BINKS POINTE PATHWAY PROJECT; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, if approved by Council, the Village of Wellington will award a contract to Ferreira Construction Southern Division company for the Binks Pointe Pathway project in the amount of \$710,576; and

WHEREAS, the Binks Pointe Pathway project requires a budget amendment to assign funds from the Road Impact fund and Governmental Capital fund to cover Wellington's required contribution of \$286,008 with the remaining funds of \$424,568 to be provided by FDOT; and

WHEREAS, a Budget Amendment, attached as Exhibit "A", has been prepared in accordance with Section 6 of Wellington's Charter and in compliance with §166.241 (4) (c) Florida's Statutes and Article VII, Purchasing Contracts, and Property Management Policies, Section 2-332 of Wellington's Code of Ordinances appropriating \$710,576 for the Binks Pointe Pathway project; and

**WHEREAS,** Wellington's Manager recommends approval of the Budget Amendment.

NOW, THEREFORE, BE IT RESOLVED BY WELLINGTON, FLORIDA'S COUNCIL that:

**SECTION 1.** The foregoing recitals are hereby affirmed and ratified as being true and correct.

**SECTION 2.** The Wellington Council hereby approves the Budget Amendment #2019-005 as set forth in Exhibit "A" and authorizes the Mayor to execute the Amendment as presented.

**SECTION 3.** This Resolution shall become effective immediately upon adoption.
