15	\$1,900,000 and is not sufficient to cover the additional costs; and
16	
17	WHEREAS, Utility fund balances of \$550,000 may be assigned by Council to
18	cover the capital project shortfall.

20 21	WHEREAS, a Budget Amendment, attached as Exhibit "A", has been prepared in accordance with Section 6 of Wellington's Charter and in compliance with §166.241 (4)
21	(c) Florida's Statutes and Article VII, Purchasing Contracts, and Property Management
22	Policies, Section 2-332 of Wellington's Code of Ordinances allocating \$550,000 from
23 24	the Utility Fund Balances to Lift Station Upgrades Capital Project and appropriating the
25	funds; and

27	WHEREAS, Wellington's Manager recommends approval of the Budget
28	Amendment.

30	NOW, THEREFORE, BE IT RESOLVED BY WELLINGTON, FLORIDA'S
31	COUNCIL that:
32 33	SECTION 1. The foregoing recitals are hereby affirmed and ratified as being true
33 34	and correct.

36	SECTION 2. The Wellington Council hereby approves the Budget Amendment
37	#2019-009 as set forth in Exhibit "A" and authorizes the Mayor to execute the
38	Amendment as presented.

40	SECTION 3. This Resolution shall become effective immediately upon adoption.
