A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE OF WELLINGTON, FLORIDA, AUTHORIZING THE MAYOR AND VILLAGE CLERK TO EXECUTE THE FIRST AMENDMENT TO INTERLOCAL AGREEMENT NO. R2002-1353 BETWEEN PALM BEACH COUNTY AND THE VILLAGE OF WELLINGTON FOR EMERGENCY OPERATIONS INTEROPERABILITY THROUGH COUNTYWIDE COMMUNICATION AMONG PUBLIC SAFETY AND GENERAL GOVERNMENTAL AGENCIES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Section 163.01, Florida Statutes, known as the "Florida Interlocal Cooperation Act of 1969," authorizes local governments to make the most efficient use of their powers by enabling them to cooperate with other localities on a basis of mutual advantage and thereby to provide services and facilities that will harmonize geographic, economic, population, and other factors influencing the needs and development of local communities; and

WHEREAS, on July 23, 2002 the Village of Wellington entered into Interlocal Agreement No. R2002-1353 with Palm Beach County which provided the Village with access to common talk groups established on Palm Beach County's Radio System; and

WHEREAS, Interlocal Agreement No. 2002-1353 between Palm Beach County and the Village of Wellington dated July 23, 2002 will expire on August 20, 2007; and

WHEREAS, a First Amendment to Interlocal Agreement extending the term of Interlocal Agreement R2002-1353 to August 20, 2012, has been prepared and is attached as Exhibit "A"; and

WHEREAS, staff recommends that Council accept and approve the Fist Amendment to Interlocal Agreement No. 2002-1353 between Palm Beach County and the Village of Wellington.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF WELLINGTON, that:

SECTION 1. The foregoing recitals are hereby affirmed and ratified.

SECTION 2. The Village Council hereby approves the Fist Amendment to Interlocal Agreement No. 2002-1353 between Palm Beach County and the Village of Wellington (attached hereto as Exhibit "A") and authorizes the Mayor and Village Clerk to execute said agreement on behalf of the Village of Wellington.

SECTION 3. This Resolution shall become effective immediately upon adoption.
