28 29	WHEPEAS the 2001 Agreement permitted Verizen wireless to install maintain		
29 30	WHEREAS, the 2001 Agreement permitted Verizon wireless to install, maintain and access equipment within the Water Treatment Plant site and on the tower; and		
30	and access equipment within the Water Treatment Fiant site and on the tower, and

33	the Village to enter into an Amendment to the License Agreement and Amended
