R2019-69 1 2 A RESOLUTION OF WELLINGTON, FLORIDA'S COUNCIL 3 APPROVING A SEASONAL PERMIT FOR THE GLOBAL 4 DRESSAGE COMPLEX, AKA EQUESTRIAN VILLAGE, AT 13466 5 SOUTH SHORE BOULEVARD FOR AN EQUESTRIAN SHOW USE 6 FROM DECEMBER 11, 2019 TO APRIL 30, 2020; AND PROVIDING 7 AN EFFECTIVE DATE. 8 9 WHEREAS, the owners of the Global Dressage Complex, aka Equestrian 10 Village, is located at 13466 South Shore Boulevard, requested a Seasonal Permit for December 11, 2019 to April 30, 2020; and 11 12 13 WHEREAS, the 59.37 acre property located at the northeast corner of South Shore Boulevard and Pierson Road is within Subarea D of the Equestrian Overlay 14 Zoning District (EOZD) and within the Wellington Planned Unit Development (PUD); and 15 16 WHEREAS, the site has a Wellington Future Land Use Map designation of 17 Commercial Recreation; and 18 19 20 WHEREAS, Wellington Council adopted Resolution No. R2013-49 designating Equestrian Village as a Commercial Equestrian Arena with conditions that required on-21 22 site and off-site improvements to be completed by December 2014; and 23 WHEREAS, Equestrian Village exercised their right to a legislative extension of 24 development order conditions; and 25 26 27 WHEREAS, in order to have beneficial use of the site for the 2019/2020 28 equestrian season is required by Wellington's Land Development regulations to obtain a Seasonal Permit in lieu of operating under the Commercial Equestrian Arena; and 29 30 WHEREAS, Section 5.3.9 of the Wellington Land Development Regulations 31 requires that Equestrian Permits that exceed 30 event days within a six (6) month 32 period are considered Seasonal Permits and require Council approval for the initial 33 request; and 34 35 WHEREAS, the site complies with the general standards in the Development 36 37 Review Manual for the Seasonal Permit; and 38 WHEREAS, Wellington Council adopted Resolution No. R2018-63 for a 39 Seasonal Permit for the 2018/2019 season on November 13, 2018 which required 40 Council approval of a request for a Seasonal Permit for the 2019/2020 equestrian 41 season if the required roadway improvements for the compatibility determination were 42 not completed. To date, roadway improvements have not been started; and 43 44 WHEREAS, the applicant is seeking approval of a Seasonal Permit for the 45 2019/2020 season which has the same on-site intensity as the previous year; and 46
