20	been prepared and is attached hereto. This Agreement covers Federal contributions of		
21	between 75% and 100%; and

24	Dorian Federally-Funded Subaward and Grant Agreement and authorize the Mayor and		
25	the Village Clerk to execute the Agreement, as well as future Amendments to the		
26	Agreement, on behalf of the Village.
