R2020-32** 2 3 A RESOLUTION OF WELLINGTON, FLORIDA'S COUNCIL 4 APPROVING AND ADOPTING THE FY 2020/2021 ANNUAL 5 ACTION PLAN FOR THE COMMUNITY DEVELOPMENT **BLOCK GRANT PROGRAM; AUTHORIZING THE VILLAGE** 6 7 MANAGER TO FORWARD THE FY 2020/2021 ANNUAL 8 ACTION PLAN TO THE UNITED STATES DEPARTMENT 9 OF HOUSING AND URBAN DEVELOPMENT: AND 10 PROVIDING AN EFFECTIVE DATE. 11 12 WHEREAS, the United States Department of Housing and Urban Development 13 (HUD) has determined that Wellington qualifies as an "entitlement community" and is 14 eligible to receive funds under the Community Development Block Grant (CDBG) 15 program; and 16 17 WHEREAS, the primary objective of HUD in awarding CDBG funds is to develop viable communities by providing funding and programs to ensure decent housing, 18 19 suitable living environments, and expanded economic opportunities, principally for low 20 and moderate income persons; and 21 22 WHEREAS, in accordance with 24 CFR 91.105, Code of Federal Regulations, 23 Wellington adopted a Citizen Participation Plan (CPP) to encourage citizen participation 24 in the preparation of the Five-Year Consolidated Plan and Annual Action Plan to 25 allocate the CDBG funding allocation; and 26 27 WHEREAS, Wellington's adopted CPP establishes criteria and outlines a 28 process for developing and amending the Five-Year Consolidated Plan and Annual 29 Action Plan which encourages citizen participation, provides citizens with reasonable 30 and timely access to local meetings and information, provides for technical assistance, 31 provides for public hearings and provides for a complaint procedure; and 32 33 WHEREAS, Wellington has developed the FY 2020/2021 CDBG Annual Action 34 Plan in compliance with its adopted CPP; and 35 36 WHEREAS, Wellington must adopt the FY 2020/2021 CDBG Annual Action Plan 37 and submit the plan to HUD for approval on or before August 16, 2020, to receive its 38 federal fiscal year 2020 CDBG entitlement allocation. 39 40 NOW, THEREFORE, BE IT RESOLVED BY WELLINGTON, FLORIDA'S
