All Proposers must disclose with their Proposal/Renewal the name of any officer, director, or agent who is also a Wellington employee. If any Proposer violates or is a party to a violation of the Wellington, Palm Beach County or Florida Code of Ethics with respect to this Proposal, such Proposer may be disqualified from performing the work described in this Proposal or from furnishing the goods or services for which the Proposal is submitted and shall be further disqualified from bidding on any future Proposals/Bids for work or for goods or services for Wellington. By signing this renewal agreement proposer acknowledges no such conflict.
