27	accordance with Section 6 of Wellington's Charter and in compliance with §166.241 (4			
28	(c) Florida's Statutes and Article VII, Purchasing Contracts, and Property Managemen			
29	Policies, Section 2-332 of Wellington's Code of Ordinances assigning Sales Surtax			
30	Fund balance of \$150,000 to the Skate Park Reconstruction project; and

32	WHEREAS, Wellington's Manager recommends approval of the Budget			
33	Amendment.
