11	WHEREAS, Section 163.01, Florida Statutes, known as the "Florida Interlocal
12	Cooperation Act of 1969," authorizes local govenments to make the most efficient use
13	of their powers by enabling them to cooperate with other localities on a basis of mutual
14	advantage and thereby to provide services and facilities that will harmonize geographic,
15	economic, population, and other factors influencing the needs and development of local
16	communities; and
17	MULTER AC the Coheel Deard of Date Deach County and Wallington recognize
18	WHEREAS , the School Board of Palm Beach County and Wellington recognize the need and benefit for each to utilize recreation facilities of the other, thereby
19 20	minimizing the duplication and maximizing the availability of the recreation facilities, and

21	WHEREAS, the recreation facilities to be utilized by the School Board and
23	Wellington include, but are not limited to gymnasiums, playgrounds, basketball courts,
24	swimming pools and other facilities; and
25	
26	WHEREAS, the Agreement provides the Principal of each of the schools and the
27	Village Manager or his or her designee the authority to schedule the use of their
28	individual facilities by the other party; and
29	
30	WHEREAS, the School Board and Wellington desire to implement this
31	Agreement unencumbered by issues unrelated to the concept of mutual use; and
32	
33	WHEREAS, the Wellington Parks and Recreation staff recommends the
34 25	Wellington Council enter into an Interlocal Agreement with the School Board of Palm
35 36	Beach County for mutual use of recreational facilities; and
30 37	WHEREAS, the Interlocal Agreement has been prepared, and a copy is attached
38	hereto as "Exhibit A."

40	NOW, THEREFORE, BE IT RESOLVED BY WELLINGTON, FLORIDA'S
