**RESOLUTION NO. R2021-20**

**A RESOLUTION OF WELLINGTON, FLORIDA'S COUNCIL  
APPROVING AND AUTHORIZING THE MAYOR AND  
CLERK TO EXECUTE AN INTERLOCAL AGREEMENT  
WITH THE SCHOOL BOARD OF PALM BEACH COUNTY  
FOR MUTUAL USE OF RECREATIONAL FACILITIES; AND  
PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, Section 163.01, Florida Statutes, known as the "Florida Interlocal Cooperation Act of 1969," authorizes local governments to make the most efficient use of their powers by enabling them to cooperate with other localities on a basis of mutual advantage and thereby to provide services and facilities that will harmonize geographic, economic, population, and other factors influencing the needs and development of local communities; and

**WHEREAS**, the School Board of Palm Beach County and Wellington recognize the need and benefit for each to utilize recreation facilities of the other, thereby minimizing the duplication and maximizing the availability of the recreation facilities, and

**WHEREAS**, the recreation facilities to be utilized by the School Board and Wellington include, but are not limited to gymnasiums, playgrounds, basketball courts, swimming pools and other facilities; and

**WHEREAS**, the Agreement provides the Principal of each of the schools and the Village Manager or his or her designee the authority to schedule the use of their individual facilities by the other party; and

**WHEREAS**, the School Board and Wellington desire to implement this Agreement unencumbered by issues unrelated to the concept of mutual use; and

**WHEREAS**, the Wellington Parks and Recreation staff recommends the Wellington Council enter into an Interlocal Agreement with the School Board of Palm Beach County for mutual use of recreational facilities; and

**WHEREAS**, the Interlocal Agreement has been prepared, and a copy is attached hereto as "Exhibit A."

**NOW, THEREFORE, BE IT RESOLVED BY WELLINGTON, FLORIDA'S COUNCIL** that:

**SECTION 1.** The foregoing recitals are hereby affirmed and ratified as being true and correct.

**SECTION 2.** The Wellington Council hereby approves the Interlocal Agreement

1 with the School Board of Palm Beach County, attached hereto as Exhibit "A" and hereby  
2 authorizes the Mayor and Clerk to execute the Agreement.
