12	WHEREAS, the United States Department of Housing and Urban Development		
13	(HUD) has determined that Wellington qualifies as an "entitlement community" and is		
14	eligible to receive funds under the Community Development Block Grant (CDBG)		
15	program; and

17	WHEREAS, the primary objective of HUD in awarding CDBG funds is to develop		
18	viable communities by providing funding and programs to ensure decent housing,		
19	suitable living environments, and expanded economic opportunities, principally for low		
20	and moderate income persons; and		
21			
22	WHEREAS, in accordance with 24 CFR 91.105, Code of Federal Regulations,		
23	Wellington has previously adopted a Citizen Participation Plan (CPP) to encourage		
24 25	citizen participation in the preparation of the Five-Year Consolidated Plan and Annual		
25 26	Action Plan to allocate the CDBG funding; and		
26 27	WHEREAS Wallington's adopted CRR actablishes criteria and autlines a		
27	WHEREAS, Wellington's adopted CPP establishes criteria and outlines a process for developing and amending the Five Year Consolidated Plan and Annual		
28 29	Action Plan which encourages citizen participation, provides citizens with reasonable		
30	and timely access to local meetings and information, provides for technical assistance,		
31	provides for public hearings and provides for a complaint procedure; and		
32	provides for public flearings and provides for a complaint procedure, and		
33	WHEREAS, Wellington has developed the FY 2021/2022 CDBG Annual Action		
34	Plan in compliance with its adopted CPP; and

36	WHEREAS, Wellington must adopt the FY 2021/2022 CDBG Annual Action Plan		
37	and submit the plan to HUD for approval on or before August 16, 2021 in order to		
38	receive its federal fiscal year 2022 CDBG entitlement allocation.
