**A RESOLUTION OF WELLINGTON, FLORIDA'S COUNCIL  
APPROVING AND AUTHORIZING THE MAYOR AND  
CLERK TO EXECUTE THE SEVENTH ADDENDUM TO THE  
LAW ENFORCEMENT SERVICES AGREEMENT WITH THE  
PALM BEACH COUNTY SHERIFF'S OFFICE FOR LAW  
ENFORCEMENT SERVICES FOR FISCAL YEAR 2021; AND  
PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, since Incorporation, Wellington has contracted with the Palm Beach County Sheriff's Office to provide law enforcement services for the Village of Wellington; and

**WHEREAS**, on August 26, 2020, Council approved the Sixth Addendum to the Law Enforcement Services Agreement (Agreement) effective October 1, 2020, for a period of one (1) year, expiring on September 30, 2021; and

**WHEREAS**, the Parties wish to amend the contract to eliminate one (1) Criminal Intelligence Analyst, convert one (1) Criminal Justice Planner to Criminal Intelligence Analyst, convert one (1) K-9 Deputy to Deputy Sheriff and set forth the adjusted consideration for the remaining Second Year of the Extended Contract Term resulting from the elimination of the Real Time Camera Center Deputy position beginning July 1, 2021 through September 30, 2021; and

**WHEREAS**, Staff recommends that the Village Council approve the proposed Seventh Addendum to Law Enforcement Services Agreement between the Village of Wellington and the Palm Beach County Sheriff's Office.

**NOW, THEREFORE, BE IT RESOLVED BY WELLINGTON, FLORIDA'S COUNCIL** that:

**SECTION 1.** The foregoing recitals are hereby affirmed and ratified as being true and correct.

**SECTION 2.** The Wellington Council hereby approves the Seventh Addendum to Law Enforcement Services Agreement for fiscal year 2021 by and between the Palm Beach County Sheriff's Office and the Village of Wellington, attached hereto as Exhibit "A", and hereby authorizes the Mayor and Clerk to execute the Agreement.

**SECTION 3.** This Resolution shall become effective immediately upon adoption.
