Vice Mayor Napoleone asked if there is a definition for seasonal rentals.

Ms. Cohen said that she does not believe that season rentals are defined in the Code.

Mr. Stillings said that they are referred to as seasonal rentals as they are not vacation rentals and they are not annual.

Mayor Gerwig said that she would like for staff to review if corporate owners are renting during the season and then renting in the off season as vacation rentals.

There were comments and discussion regarding the vacation rental and registration.

Councilman McGovern asked Ms. Cohen if the Village is within the statutory purview.

Ms. Cohen said that there is no prohibition against it.

Councilman McGovern commented his concerns about the Village's inability to enforce and the ability to inform people that they will have to do this.

Mr. Stillings responded to Councilman McGovern's comment.

Ms. Cohen discussed certain violations like parking being cited by the citation method without first having to give a warning.

Mr. Barnes mentioned that there is a service to identify the actual locations. He said that staff will continue to track the locations to make sure that they are registered. The Village will coordinate with the Palm Beach County Sheriff's Office (PBSO) for enforcement.

There were comments and discussion regarding enforcement, registration and the keeping the residents and representatives of the rentals updated.
