Ms. Tuckwood gave an update on recent and upcoming programs and events.

Mr. Nebb mentioned it is a Village Council meeting and they would be voting on the Senior Club Funding.

Mr. Soto said he has information on County programs and would pass it along so a partnership can be created.

Ms. McCue asked if there were a lot of calls from seniors for assistance. Ms. Tuckwood mentioned that the Hurricane Helpers program was able to help a number of residents but that the demand was far higher than the program was able to handle.

Mr. Trager asked if it was possible to do a CPR class. Ms. Tuckwood said she would look into it.

Mr. Trager also asked about plans for getting information to the public. Ms. Tuckwood said they planned to use the newsletter, the Golden Banner, newspapers etc.

Ms. Schwartz asked how the newsletter gets to the seniors because she had not received one. Ms. Tuckwood said it goes in the mail and that if she could be provided with names and addresses of people who did not receive the newsletter she could be sure they were added to the mailing list.
