# III. APPROVAL OF MINUTES

A motion was made by Dr. Charles Sandell, seconded by Ms. Kay Brown approving the Minutes of the March 1, 2017 Tree Board Meeting, as corrected, approved unanimously by Debbie Evans, Kay Brown, Richard Cosola, Charles Sandell (4-0), with Stormi Bivin, William Gross and Joan Kaplan absent.

### IV. STAFF UPDATES

Mr. Brian Hopper updated the Tree Board on recent plantings since the last Tree Board Meeting on March 1, 2017, the Earth Day/Arbor Day event on April 22, 2017 and the tree seedling Giveaways to Wellington schools. Mr. Hopper also distributed a Tree Planting List, which documents trees planted in Wellington by the Landscape Division.

Ms. Debbie Evans asked staff to add Eagle Arts Academy to the list of schools to receive the annual tree seedling giveaways.

#### V. OLD BUSINESS

Award form with the additional category, "Treemendous Tree," approved unanimously by Debbie Evans, Kay Brown, Richard Cosola, Charles Sandell (4-0), with Stormi Bivin, William Gross and Joan Kaplan absent.
