# Village Council Workshop

### 1. CALL TO ORDER

Mayor Gerwig called the meeting to order at 4:03 p.m.

Council Members in Attendance: Anne Gerwig, Mayor; Michael Drahos, Vice Mayor; John McGovern, Councilman; Michael Napoleone, Councilman and Tanya Siskind, Councilwoman.

Mayor Gerwig called for a moment of silence in honor of Former Mayor Thomas Wenham.

# 2. PLEDGE OF ALLEGIANCE

Mayor Gerwig led the Pledge of Allegiance.

# 3. REVIEW OF COUNCIL AGENDA

Mr. Barnes introduced the agenda for the January 10, 2023 Regular Council Meeting for review.

A. 22-5670 PRESENTATION OF POLO PARK MIDDLE SCHOOL ROBOTICS TEAMS PROJECT

Mr. Barnes introduced the item. He stated that this was the Presentation of Polo Park Middle School Robotics Teams Project. He advised that the groups have been here in the past and they will be present at tomorrow night's meeting to present their projects.

B. 22-5677 A PROCLAMATION OF THE VILLAGE COUNCIL OF WELLINGTON, FLORIDA RECOGNIZING MICHAEL O'DELL ON HIS RETIREMENT AND DEDICATION TO THE VILLAGE OF WELLINGTON

Mr. Barnes introduced the item. He stated that this was a Proclamation of the Village Council of Wellington, Florida Recognizing Michael O'Dell on His Retirement and Dedication to the Village of Wellington.

In addition, Mr. Barnes noted that an item will be added regarding the proclamation request received for the Thurgood Marshall Masonic Lodge #121 that serves the Wellington and the Royal Palm Beach areas. He mentioned that the lodge was granted their Charter and recently held an inaugural meeting. Staff is confirming attendance; otherwise the proclamation will be placed on the Consent Agenda.

Mayor Gerwig advised that the attendance has been confirmed.

Mr. Barnes advised that this will added to the agenda as Item 5C.

Consulting Services for the Meter System Assessment and Strategic

Plan Project.

Ms. Panse explained the item.

Mayor Gerwig asked if the badger meter is currently being used.

Ms. Panse answered a question from Mayor Gerwig.

Mayor Gerwig commented on the wear and tear of the system.

Ms. Panse responded to Mayor Gerwig's comments.

Councilman McGovern commented on the replacement of the badger meters over the past several years.

Mayor Gerwig inquired if there are issues with the warranty on the system.

Ms. Panse responded to Mayor Gerwig's inquiry.

Ms. Quickel advised that staff is working on the 2024 Budget season which will include the 5-Year Capital Improvement Plan which includes the meter project.

Ms. Panse continued to explain the item.

Councilwoman Siskind inquired if this will be included in the Utility Budget.

Ms. Quickel responded to Councilwoman Siskind's inquiry.

**G**. <u>22-5669</u>

AUTHORIZATION TO PROCEED WITH FORECLOSURE OF LIEN AGAINST PALM BEACH POLO, INC. ARISING FROM CODE COMPLIANCE CASE NO: 15-3902 (THE "DOG PARK CASE")

Mr. Barnes introduced the item. He stated that this was the Authorization to Proceed with Foreclosure of Lien Against Palm Beach Polo, Inc. Arising from Code Compliance Case No. 15-3902 (The "Dog Park Case").

Ms. Cohen explained the item. She noted the lien amount of \$446,608.87. She advised that under Florida Statutes, Counsel will have to request authorization from the Special Magistrate or Code Enforcement Board in order to move forward with the foreclosure proceedings. She advised that Counsel is seeking authorization from Council to seek an order authorizing the foreclosure.

Mayor Gerwig inquired if the lien has been reduced by the Special Magistrate.

Ms. Cohen responded to Mayor Gerwig's inquiry. She noted that there is \$89,808.67 being held in escrow.

There were comments and discussion by Council regarding the amount.

Ms. Cohen responded to Council comments and questions.

### H. 22-5525

RESOLUTION NO. R2022-66 (ADOPTION OF A BLUEWAYS MASTER PLAN)

A RESOLUTION OF WELLINGTON, FLORIDA'S COUNCIL, ADOPTING THE BLUEWAYS MASTER PLAN; AND PROVIDING FOR AN EFFECTIVE DATE.

Mr. Barnes introduced the item. He stated that this was the Resolution No. R2022-66 (Adoption of A Blueways Master Plan). Mr. Barnes noted that there are members here of the public in attendance to listen to the presentation; and noted that Public Comment is not allowed during Agenda Review however the those in attendance are filling out comments cards for tomorrow night's Village Council meeting.

Mayor Gerwig stated that comments can be left and will be read into the record at tomorrow night's meeting if the box is checked.

Mr. Barnes advised that the public is welcome to attend tomorrow night's meeting.

Mr. O'Dell explained the item. He presented a PowerPoint presentation of Wellington Blueways Master Plan.

Mayor Gerwig asked if the canals are navigable.

Mr. O'Dell responded to Mayor Gerwig's question. Mr. O'Dell continued with the presentation.

Mayor Gerwig asked if pontoon boats are low profile.

Mr. O'Dell responded to the question from Mayor Gerwig.

Councilman Napoleone commented that this a great start as an aspirational goal with linking the two lakes together.

Mayor Gerwig mentioned her concerns with a bridge due to the height that would be required.

Mr. O'Dell noted that staff have looked at traffic calming in addition to working with the Engineering Department to reduce speed and move traffic from cutting through the Village into other locations.

Mayor Gerwig inquired whether a box culvert would be added and then a bridge added later.

Mr. O'Dell responded to Mayor Gerwig's inquiry.

There was discussion regarding box culverts and the height requirement for the bridge.

Mr. O'Dell and Mr. Reinsvold responded to comments and questions from Mayor Gerwig.

Mayor Gerwig said that she is pulling the item.

There was discussion on pulling the item and bridge height requirements.

Mr. O'Dell noted the location of the box culverts and locations that are being looked at for two bridges. .

Mayor Gerwig stated her concerns regarding the property owners.

Mr. Reinsvold responded to Mayor Gerwig's comments.

Vice Mayor Drahos commented that he does not think that Council is being asked to commit to a specific bridge or plan; it is a long term aspirational plan.

Mayor Gerwig advised that she is available to meet with staff.

Mr. O'Dell said he will set up a meeting.

Councilman McGovern asked Mayor Gerwig if the item is being pulled.

Mayor Gerwig responded to Councilman McGovern's question.

#### DISCUSSION LAKE WELLINGTON PROFESSIONAL CENTER

Councilman McGovern asked if any payment has been made out of the fund back to the General fund for the repayment.

Ms. Quickel answered the question from Councilman McGovern.

Vice Mayor Drahos asked if the rent has been raised at all for the tenants.

Ms. Quickel answered the question from Vice Mayor Drahos.

Mayor Gerwig asked why would tenants' rent be abnormally low.

Ms. Quickel answered the question from Mayor Gerwig.

There was discussion regarding the notice letter.

Ms. Quickel responded to Council comments and questions.
