(representing Wellington Athletics, LLC.); Matt Boles from RBC Financing; and Jim Arnold from The Sports Facility Advisors (available via Zoom). She stated the entire team has worked on this.

Ms. Cohen reiterated that the whole team reviewed the documents and provided alot of input.
