**ITEM: AUTHORIZATION TO RENEW CONTRACTS FOR LANDSCAPE MAINTENANCE SERVICES FOR FACILITIES, PRIMARY ROADS, UTILITY SITES, CANALS AND EQUESTRIAN TRAILS**

**REQUEST:** Authorization to renew contracts for landscape maintenance services for facilities, primary roads, utility sites, canals and equestrian trails for \$740,232 annually.

**EXPLANATION:** The Public Works and Utility Departments currently utilize contracts for landscape maintenance services for facilities, primary roads, utility sites, canals and equestrian trails. The current contracts expire September 30, 2021.

On September 11, 2018, Council awarded Bid #021-18/DZ to Gardenscapes of the Palm Beaches (Western Community Local Vendor) to provide landscape maintenance services for facilities and utility sites and Wellington Pro Lawn (Western Community Local Vendor) to maintain primary roadways, canals and equestrian trails.

Staff is requesting authorization to exercise the first renewal option with Gardenscapes of the Palm Beaches to provide landscape maintenance services for facilities and utility sites and Wellington Pro Lawn to maintain primary roadways, canals and equestrian trails through September 30, 2022 with no price increases.
