REQUEST: Approval of Ordinance No. 2018-08 to repeal and replace Articles 7 - Site Development Standards in its entirety.

EXPLANATION: As part of the re-write of the Land Development Regulations, this ordinance proposes to modify the Site Development Standards section of the LDR. Additionally, the packet includes the Landscape Manual.

On September 12, 2018, this item was heard by the Planning, Zoning, and Adjustment Board. The Board recommended approval, unanimously, with a 7-0 vote.
