ITEM: ORDINANCES APPROVING REFERENDUM QUESTIONS AMENDING THE VILLAGE CHARTER

REQUEST: Adoption of ordinances approving referendum questions amending the Village Charter.

EXPLANATION: This is the second reading and adoption of four questions amending various sections of the Charter to be presented to the electorate at the March 15, 2016 election.

Staff is seeking approval from Council of the four ordinances to be presented to the electorate as follows:

- Α. ORDINANCE 2015-15A (FILING OF VACANCIES) **ORDINANCE** OF FLORIDA'S WELLINGTON. COUNCIL **PROPOSING AMENDMENTS** TO **CHARTER** SECTION 5 OF WELLINGTON'S MUNICIPAL RELATING TO **OF VACANCIES FOR** AND **COUNCILMEMBERS** BY **AMENDING** MAYOR SUBSECTION G, "VACANCIES: **FORFEITURE OF** OFFICE: SUSPENSION: **CHARTER** FILLING OF **VACANCIES**" OF WELLINGTON'S TO **PERMIT** THE **FILLING** OF **VACANCIES** THE **OFFICE** OF COUNCILMEMBER THE IN PROVIDING FOR THE SUBMISSION OF THE SAME MANNER AS THE MAYOR: PROPOSED CHARTER AMENDMENT TO THE **ELECTORS** OF WELLINGTON 2016; PROVIDING FOR FILING THE ELECTION TO BE HELD ON MARCH 15.
