EXPLANATION: The agent, Don Hearing of Cotleur and Hearing, Inc., on behalf of the applicant, W & W Equestrian Club, LLC, is seeking Rezoning approval for the proposed Winding Trails project located on the east side of Aero Club Drive between Greenbriar Boulevard and South Club Drive. The request is to amend the Zoning designation of Winding Trails from Agricultural Residential/Planned Unit Development (AR/PUD) to Agricultural Residential/Planned Unit Development/Equestrian Overlay Zoning District (AR/PUD/EOZD). Additionally, the request is to identify Winding Trails as part of Subarea F.

A recommendation from the Equestrian Preserve Committee was not included because the petitions will not be heard until the September 7, 2016 Equestrian Preserve Committee meeting. A memo will be provided to members of the PZAB with the results of the EPC meeting prior to the scheduled PZAB meeting.

SUMMARY: Staff is seeking approval of the Rezoning of Winding Trails (FKA The Landing of Wellington PUD Executive Course) to amend the Zoning designation of Winding Trails from Agricultural Residential/Planned Unit Development (AR/PUD) to Agricultural Residential/Planned Unit Development/Equestrian Overlay Zoning District (AR/PUD/EOZD) and to designate Winding Trails as Subarea F of the EOZD.
