SUMMARY: The agent, Michael Sexton, Sexton Engineering, on behalf of the owner, Equestrian Sports Production, is requesting a Comprehensive Plan Text Amendment (CPTA) approval to amend the Land Use Element to create Floating Zoning Districts and to amend the Equestrian Element to define the Equestrian Competition Floating District, providing goals and policies that establish the framework for this district.

The petition will be presented to the Equestrian Preserve Committee (EPC) on April 5, 2017. A memo will be sent to PZAB after the meeting summarizing the recommendations of the EPC.
