**I. RESOLUTION NO. **V. RESOLUTION NO. **REQUEST:** Approval of Resolution numbers AC2017-05, AC2017-06, R2017-37, R2017-38 and R2017-39 as presented adopting the FY 2017/2018 budgets, assessment rates and appointing Mayor Anne Gerwig as the official authorized representative to certify the non-ad valorem assessment rolls.

**EXPLANATION:**

- I. Resolution No. AC2017-05 sets forth the Acme Improvement District budget and related non-ad valorem assessment for Fiscal Year 2017/2018.

The budget for Acme Improvement District totals approximately **\$6.79 million** at the non-ad valorem

assessment rate of **\$230 per assessment unit**. This is the same as last year's rate and the proposed assessment approved for Truth in Millage (TRIM) purposes on July 11, 2017.

- II. Resolution No. AC2017-06 adopts the Water and Wastewater utility budget for Fiscal Year 2017/2018. The budget for the utility totals **\$33.84 million** excluding depreciation.

**Pursuant to the 2010 rate study and the local area CPI, a 2.5% index in water and wastewater rates will be effective for FY 2017/2018. The utility rate schedule is shown with the indexed rates in Exhibit A of the resolution.**

- III. Resolution No. R2017-37 adopts the Solid Waste Collection Program budget and related non-ad valorem assessment rates for Fiscal Year 2017/2018.

The budget for the Solid Waste Collection Program totals approximately **\$4.05 million** excluding depreciation.

Solid Waste assessment rates are proposed at **\$135 per curbside unit and \$100 per containerized unit**. This is the same as last year's rate and the proposed assessment approved for TRIM purposes on July 11, 2017.

Exhibit B for Resolution No. R2017-37 sets forth the rates for FY 2017/2018. The Resolution provides for the Solid Waste Collection Program non ad-valorem assessment rates and special services rates; and authorizes Wellington to collect, at the time of issuance of the Certificate of Occupancy to newly constructed residential units, the same Solid Waste Collection and Recycling fee on a pro-rata basis, as all other residential units pay through the annual property assessment process. Funds received from the collection of the disposal fee will be used to compensate the Contractor for their disposal costs not covered by fees collected through the annual property assessment from assessed residential units. The fee collected is at the same rate as that collected by the Solid Waste Authority of Palm Beach County for disposal costs.

Exhibit C for the Resolution presents the Solid Waste Disposal Service rates for FY 2017/2018. The Solid Waste Authority assessment for single family units is proposed to increase to \$174 (up \$4) per unit and \$100 (up \$3) per multifamily/containerized unit.

- IV. Resolution No. R2017-38 adopts the Lake Wellington Professional Centre budget for Fiscal Year 2017/2018. The budget for the enterprise totals **\$737,800** excluding depreciation.
- V. Resolution No. R2017-39 adopts the Saddle Trail Park Neighborhood Improvement District non-ad valorem assessment rates for Fiscal Year 2017/2018. The budget for the assessment revenue totals **\$266,536 (adjusted for 5% discounts)** in the Debt Service Fund and will be assigned to payment of the **15-year bond issued in 2016**. The Debt Service Fund allocations will be adopted at the September budget hearings for governmental funds.
